FIRST AMENDMENT TO DEPARTMENT OF TRANSPORTATION AGREEMENT NO. 250043 FOR TRIBAL MONITORING SERVICES FOR THE REDEMEYER ROAD EXTENSION PROJECT, COUNTY ROAD 215A

This first Amendment to Department of Transportation (DOT) Agreement Number (No.) 250043 is entered into by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and **Coyote Valley Band of Pomo Indians**, hereinafter referred to as "CONSULTANT," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. 250043 was entered into on September 3, 2025 (the "Agreement") for a total amount of \$48,840; and

WHEREAS, upon execution of this document by COUNTY and CONSULTANT, this First Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, CONSULTANT provided Tribal Monitoring Services during exploratory cultural field investigations, Extended Phase I (XPI); and

WHEREAS, additional Tribal Monitoring Services are required to complete the Phase II Exploration; and

WHEREAS, it is the desire of COUNTY and CONSULTANT to extend the termination date from December 31, 2025 to December 31, 2026; and

WHEREAS, it is the desire of COUNTY and CONSULTANT to increase the total amount payable by \$64,160 from \$48,840 to \$113,000.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the Agreement is hereby extended from December 31, 2025 to December 31, 2026.
- 2. The total contracted amount set out in the Agreement is hereby increased by \$64,160 from \$48,840 to \$113,000.

All other terms and conditions of the Agreement shall remain in full force and effect.
