2/21/2019 SUMMARY OF PROPOSED ORDINANCE AN URGENCY ORDINANCE OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS ESTABLISHING A TEMPORARY MORATORIUM ON THE CULTIVATION OF INDUSTRI-AL HEMP WITHIN THE UNINCOR-PORATED AREAS OF MENDOCINO COUNTY PENDING THE STUDY AND CONSIDERATION OF LAND USE AND OTHER REGULATIONS PERTAINING TO SUCH CULTIVA-TION TION

This urgency ordinance adopts a moratorium on the cultivation of industrial hemp, as defined in the ordinance, for a period of 45 days. Under the ordinance, the cultivation of industrial hemp for any purposes is prohibited and the County shall not issue any permit, registration or ap-proval related to industrial hemp cultivation. Cultivation of industrial hemp in violation of the ordinance constitute a pub-lic nuisance which may be en-forced or abated by any means available by law, including but not limited to Mendocino County Code Chapters 1.08 and 8.76. cultivation of industrial hemp Code Chapters 1.08 and 8.76. The ordinance contains findings establishing the urgency as re-quired by Government Code sec-tion 65858. If adopted, the ordi-nance will be effective for a 45day period, which may be ex-tended by the Board of Supervi-sors following notice and a public hearing.

The proposed ordinance is scheduled for adoption on February 26, 2019.
