NORTH COAST RESOURCE PARTNERSHIP (NCRP)

- Initiated in 2005
- Coalition of Tribes & Counties
- NCRP = Region 1, North Coast RWQCB boundary
- Mission: Enhance Communities & Watersheds
- Memorandum of Mutual Understandings (MoMU)
- Regional Contract Administration: County of Humboldt
- Over \$130 million awarded: planning, capacity, implementation



GOVERNANCE & TECHNICAL REVIEW

Leadership Council (LC)

- Decision-making by locally elected officials: 2 Supervisors per county & 3 representatives elected by North Coast Tribes

Executive Committee (EC)

- Co-chair, Co-Vice-chair, and EC positions: tribal & county

Technical Peer Review Committee (TPRC)

- Technical & agency staff appointed from each County & 3 representatives elected by regional Tribes
- Review/advise on technical & planning documents, recommend projects for funding

NCRP Ad Hoc Committees

- Provide guidance and input on staff work
- Active: Regional Forest and Fire Resilience, Illegal Cannabis

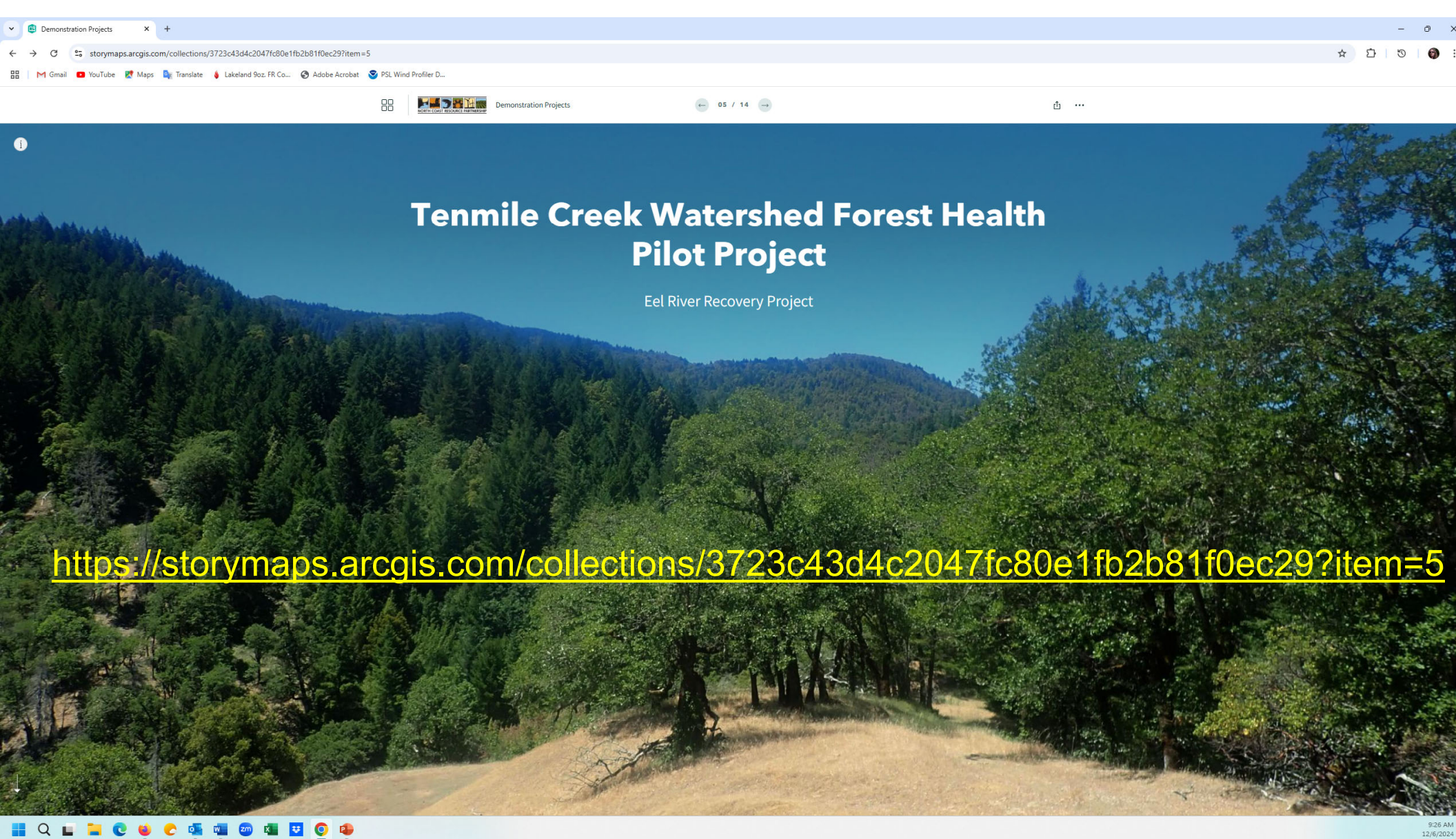
