**THIRD AMENDMENT TO COUNTY OF MENDOCINO  
AGREEMENT NO. BOS-23-209**

This third Amendment to Agreement No. BOS-23-209 is entered into by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and **NOKIA OF AMERICA CORPORATION**, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. BOS-23-209 was entered into on December 19, 2023 (the "Initial Agreement"); and

WHEREAS, First Amendment to Agreement No. BOS-23-209 was entered into on October 2, 2024 (the "First Amendment") extending the termination date from December 31, 2024, to June 30, 2025; and

WHEREAS, Second Amendment to Agreement No. BOS-23-209 was entered into on March 24, 2025 (the "Second Amendment") increasing the total amount by \$34,870.41 for a new total of \$2,183,567.99; and

WHEREAS, the Initial Agreement, First Amendment and Second Amendment are referred to as the Agreement; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this third Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date from June 30, 2025, to January 30, 2026; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total amount payable by \$109,440.00 from \$2,183,567.99 to \$2,293,007.99.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the Agreement is hereby extended from June 30, 2025, to January 30, 2026.
2. The total contracted amount set out in the Agreement is hereby increased by \$109,440.00 from \$2,183,567.99 to \$2,293,007.99.
3. The Exhibit C, Statement of Work 22.US.317668.04, set out in the Agreement is hereby amended to include the equipment and services stated in Exhibit A,

Additions of Statement of Work, attached hereto.

4. The Exhibit D, CONTRACTOR Quote , set out on the Agreement is hereby amended to include the additional equipment and services stated in Exhibit B, Additional Quote Terms, attached hereto.

All other terms and conditions of the Agreement shall remain in full force and effect
