

## **RESOLUTION NO. 23-101**

### **RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING THE MENDOCINO COUNTY BEHAVIORAL HEALTH AND RECOVERY SERVICES AGENCY DIRECTOR TO SIGN AS AN AGENT ON BEHALF OF THE COUNTY OF MENDOCINO FOR THE DRUG MEDI-CAL ORGANIZED DELIVERY SYSTEM AGREEMENT WITH CALIFORNIA DEPARTMENT OF HEALTH CARE SERVICES, AMENDMENT NO. 1 TO AGREEMENT NUMBER 20-10185 (DRUG MEDI-CAL ORGANIZED DELIVERY SYSTEM AGREEMENT)**

WHEREAS, the Board of Supervisors of the County of Mendocino (hereinafter "Board") has read the proposed Agreement Amendment between California Department of Health Care Services (hereinafter "DHCS") and the Mendocino County Behavioral Health and Recovery Services (hereinafter "BHRS"), Amendment No. 1 to Agreement Number 20-10185 (hereinafter "Agreement"); and

WHEREAS, the Board acknowledges the benefits and responsibilities to be shared by both parties to said Agreement; and

WHEREAS, with this Agreement DHCS will continue to authorize BHRS to contract with Partnership Health Plan of California to administer the Substance Use Disorders Treatment Organized Delivery System services on behalf of the County of Mendocino and for Partnership Health Plan of California to continue to contract with the County of Mendocino to provide Substance Use Disorder Treatment services; and

WHEREAS, the objective of this Agreement is to continue to make Drug Medi-Cal Organized Delivery System services available to Medi-Cal beneficiaries through utilization of federal and state funds available pursuant to Title XIX and Title XXI of the Social Security Act for reimbursable covered services rendered by certified Drug Medi-Cal provider; and

WHEREAS, Mendocino County has contracted with the State of California, Department of Health Care Services for the purpose of identifying and providing covered Drug Medi-Cal Organized Delivery System (DMC-ODS) services for substance use disorder (SUD) treatment in the County's service area pursuant to Sections 11848.5(a) and (b) of the Health and Safety Code, Sections 14021.51-14021.53 and 14124.20-14124.25 of the Welfare and Institutions Code, Part 438 of the Code of Federal Regulations and the Specialty Terms and Conditions of the State of California DMC ODS waiver; and

WHEREAS, this Agreement is further controlled by applicable provisions of (a) the Welfare and Institutions Code Chapter 7, Sections 14000 et seq. in particular but not limited to Sections 14100.2, 14021, 14021.5, 14021.6, 14043, et seq., and (b) Division 4 of Title 9 of the California Code of Regulations.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby authorizes the Mendocino County Behavioral Health and Recovery Services Director to sign and execute Amendment No. 1 to Agreement Number 20-10185 with DHCS and any amendments thereto that do not increase the maximum dollar amount of the Agreement.
