AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 19-195

This Amendment to BOS Agreement No. 19-195 is entered into this day of May, 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Economic Development and Financing Corporation, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 19-195 was entered into on April 1, 2019; and

WHEREAS, upon execution of this document by the Chair <u>Economic Development and Financing Corporation</u> of the Mendocino County Board of Supervisors and <u>Economic Development and Financing Corporation Center</u>, this document will become part of the aforementioned contract and shall be incorporated therein;

WHEREAS, the COUNTY and CONTRACTOR desire to make the following amendments to BOS Agreement No. 19-195;

NOW, THEREFORE, we agree as follows:

- 1. Any and all mention of broadband activities shall be removed. Sections 2A, 2B, and 6 in Exhibit A shall be deleted. "Implement of Digital Infrastructure Strategic Plan objective to improve recovery and resiliency" in Section 1 of Exhibit B shall be deleted.
- Any and all mention of "County Economic Recovery Coordinator" shall be changed to "Economic Recovery Coordinator." For this particular contract, the Economic Recovery Coordinator shall be the contractor and its designated representative awarded for the services under Request for Proposal DR-19-04.

All other terms and conditions of BOS Agreement No. <u>19-195</u> shall remain in full force and effect.
