

RESOLUTION NO. 25-170

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS APPROVING DEPARTMENT OF TRANSPORTATION AGREEMENT NUMBER 250037, WITH ROUTEWARE, INC., FOR A RECYCLIST SOFTWARE THREE-YEAR PROGRAM SUBSCRIPTION, IN THE AMOUNT OF \$71,731.54, FOR THE TERM OF MAY 1, 2026, THROUGH APRIL 30, 2029 (COUNTYWIDE)

WHEREAS, Senate Bill (SB) 1383 represents the largest and most prescriptive waste management legislative update in the last 30 years; and

WHEREAS, successful compliance with SB 1383 requires a significant and coordinated effort countywide; and

WHEREAS, due to the numerous actions and programs required to be implemented by jurisdictions under SB 1383, the County of Mendocino currently uses Recyclist Software to track compliance progress and meet reporting requirements; and

WHEREAS, Recyclist's Program Tracker meets all the record-keeping and reporting requirements of SB 1383, Assembly Bill (AB) 341 (Mandatory Commercial Recycling) and AB 1826 (Mandatory Commercial Organics Recycling); and

WHEREAS, Department of Transportation (DOT) Agreement Number (No.) 250037 provides for an additional three-year program subscription from May 1, 2026, through April 30, 2029; and

WHEREAS, DOT has received grant funds from CalRecycle which are anticipated to cover the entire three-year subscription cost and has budgeted accordingly.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Approves DOT Agreement No. 250037, with Routeware, Inc., for a Recyclist Software Three-Year Program Subscription in the amount of \$71,731.54, for the term of May 1, 2026, through April 30, 2029; and
