## **RESOLUTION NO. 22-210**

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS FOR TEMPORARY ROAD CLOSURE OF DOGWOOD TERRACE, COUNTY ROAD, 641A, AND DOGWOOD LANE, COUNTY ROAD, 641B, FOR 18 MONTHS TO PREVENT SERIOUS AND CONTINUAL ILLEGAL DUMPING (BROOKTRAILS AREA)

WHEREAS, Dogwood Terrace, County Road (CR) 641A, and Dogwood Lane CR 641B, in Brooktrails, require closure to vehicular traffic to prevent serious and continual illegal dumping; and

WHEREAS, because vehicle traffic contributes to that illegal dumping, the County Sheriff's Department, California Highway Patrol, and the Brooktrails Township Fire Department also recommend closure of Dogwood Terrace and Dogwood Lane; and

WHEREAS, California Vehicle Code section 21101.4 provides for temporary closure of a County Road following a public hearing and the making of certain findings; and

WHEREAS, Mendocino County Department of Transportation (MCDoT) staff have determined that Dogwood Terrace and Dogwood Lane have not been designated as a through highway or arterial street; the closure of Dogwood Terrace and Dogwood Lane will not impact traffic flow, safety on the adjacent streets or in the surrounding neighborhoods, the operation of emergency vehicles, the performance of municipal or public utility services, or the delivery of freight by commercial vehicles in the area; and

WHEREAS, a public hearing has been held on this proposed closure of Dogwood Terrace and Dogwood Lane, notice of which was mailed to the residents and owners, as shown on the last equalized assessment roll, of property adjacent to those portions of roadway.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors, based on the record before it and pursuant to State of California Vehicle Code section 21101.4 hereby:

## 1. Finds and determines that:

- A. Based on the recommendation of the County Sheriff's Department and California Highway Patrol, there is serious and continual illegal dumping is occurring on Dogwood Terrace, CR 641A, and Dogwood Lane, CR 641B; and
- B. Neither of the above-described Dogwood Terrace and Dogwood Lane have been designated as a through highway or arterial street; and
- C. Vehicle traffic contributes to the illegal dumping on the above-described Dogwood Terrace and Dogwood Lane; and
- D. The closure of the above-described Dogwood Terrace and Dogwood Lane will not impact traffic flow, safety on the adjacent streets or in the surrounding neighborhoods, the performance of municipal or public utility services to, or the delivery of freight by commercial vehicles in the area of those sections of roadway.
- 2. Authorizes an 18-month temporary closure of Dogwood Terrace, CR 641A and Dogwood Lane, CR 641B, beginning October 18, 2022, and ending April 18, 2024.
