

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. JA-J19-012 & BOS 20-078**

This Second Amendment to Agreement No. JA-J19-012 and BOS 20-078 is entered into this _____ day of _____, 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and In-Custody Transportation Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. JA-J19-012 and BOS 20-078 was entered into on July 1, 2019 and June 1, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and the CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

NOW, THEREFORE, we agree as follows:

1. **Amount of agreement:** The amount set out in the original Agreement No. JA-J19-012 and BOS 20-078 will be changed from \$100,000 to \$150,000 with the addition of \$50,000.
2. **Payment Terms:** The Payment Terms, Exhibit B, number 5, set out in the original Agreement No. JA-J19-012 and BOS 20-078 has been altered and a new Payment Terms, Exhibit B, is attached herein with the changes denoted in bold font.

All other terms and conditions of BOS Agreement No. JA-J19-012 and BOS 20-078 shall remain in full force and effect.

2. CONTRACTOR provides:

a. 50% discount off pick up fee, if additional person is picked up from the same facility.

3. Per Exhibit A, Definition of Services B. 1. a-d, COUNTY will reimburse CONTRACTOR for applicable costs as stated in the aforementioned section of Exhibit A.
