

**AMENDMENT TO COUNTY OF MENDOCINO
STANDARD SERVICES AGREEMENT NO. EO# 17-80**

This Amendment to Agreement No. EO# 17-80 is entered into this 17th day of November, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Belfor Environmental, Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. EO# 17-80 was entered into on September 23, 2016; and

WHEREAS, upon execution of this document by the County of Mendocino and the Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of the CONTRACTOR and the COUNTY to alter the scope of work set out in the original Agreement No. EO# 17-80 to include the preparation for and installation of epoxy moisture/vapor barrier in affected areas: and

WHEREAS, the original amount set out in Agreement No. EO# 17-80 will be increased from One Hundred Forty Nine Thousand Nine Hundred Thirteen Dollars and Twenty Seven cents (\$149,913.27) to Four Hundred Forty Five Thousand Three Hundred Sixty One Dollars and Forty One cents (\$445,361.41).

NOW, THEREFORE, we agree as follows:

1. The scope of work set out in the original Agreement No. EO# 17-80 will include the preparation for and installation of epoxy moisture/vapor barrier in affected areas.
2. The compensation payable to CONTRACTOR shall be increased by Two Hundred Ninety Five Thousand Four Hundred Forty Eight Dollars and Fourteen cents (\$295,448.14) for a new not to exceed amount of Four Hundred Forty Five Thousand Three Hundred Sixty One Dollars and Forty One cents (\$445,361.41).

All other terms and conditions of Agreement No. EO# 17-80 shall remain in full force and effect.
