

RESOLUTION NO. 25-012

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS SITTING AS THE AIR QUALITY MANAGEMENT DISTRICT BOARD AUTHORIZING THE AIR QUALITY MANAGEMENT DISTRICT TO ABOLISH THE CLASSIFICATION OF AIR QUALITY MANAGEMENT DISTRICT PROGRAM MANAGER WITHIN THE COUNTY OF MENDOCINO

WHEREAS, the Board of Supervisors has adopted Resolution No. 24-098 which sets forth the classifications, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the desire of the Board of Supervisors to amend said resolution to meet the needs of County service; and

WHEREAS, there are no current incumbents allocated to the classifications of Air Quality Management District; and

WHEREAS, the Civil Service Commission approved the abolishment of dormant Civil Service Classifications of Air Quality Management District, at its December, 18, 2024, public meeting; and

WHEREAS, Human Resources has fulfilled its obligations with affected bargaining units under Myers Milias Brown Act (MMBA).

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors sitting in as the Air Quality Management District Board hereby authorize the abolishment of dormant classification listed below, or as amended by the Board.
