**AMENDMENT TO COUNTY OF MENDOCINO
BOARD OF SUPERVISORS AGREEMENT NO. 22-019**

This Amendment to BOS Agreement No. 22-019 is entered into this 26th day of April, 2022, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Redwood Valley Calpella Fire District**, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 22-019 was entered into on January 25, 2022; and

WHEREAS, upon execution of this document by the County of Mendocino and the CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of the CONTRACTOR and the COUNTY to extend the termination date set out in the original BOS Agreement No. 22-019, from June 30, 2022 to June 30 2023; and

WHEREAS, CONTRACTOR will be able to have the Type 1 Pumper Water Truck, the Type 6 Wildland Brush Truck and the patrol engine assembled and delivered.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 22-019 is hereby extended from June 30, 2022 to June 30, 2023.

All other terms and conditions of BOS Agreement No. 22-019 shall remain in full force and effect.
