

**AMENDMENT TO COUNTY OF MENDOCINO
STANDARD SERVICES AGREEMENTS NOS. SS-S16-051,
SS-S16-051-A1 PURCHASING AGENT NO. 17-94, and
SS-S16-051-A2 PURCHASING AGENT NO. 17-109A1**

This Amendment to Agreements Nos. SS-S16-051, SS-S16-051-A1 Purchasing Agent No. 17-94, and SS-S16-051-A2 Purchasing Agent No. 17-109A1 is entered into this - 16 day of May, 2017, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Communique**, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. SS-S16-051 was entered into on August 11, 2016; and

WHEREAS, Agreement No. SS-S16-051-A1, Purchasing Agent No. 17-94 was entered into on December 21, 2016; and

WHEREAS, Agreement No. SS-S16-051-A2, Purchasing Agent No. 17-109A1 was entered into on March 13, 2017; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, CONTRACTOR will provide sign language interpretation services.

NOW, THEREFORE, we agree as follows:

Amount of agreement: The amount set out in the original Agreements Nos. SS-S16-051, SS-S16-051-A1 Purchasing Agent No. 17-94, and SS-S16-051-A2 Purchasing Agent No. 17-109A1 will be changed from \$50,000 to \$80,000.

Expected outcome of amendment: Communique will continue to provide sign language interpretation services for one hearing-impaired client who needs to access services through Family and Children's Services (FCS) and Behavioral Health and Recovery Services (BHRS) for his/her FCS dependency court case.

All other terms and conditions of Contract Agreements Nos. SS-S16-051, SS-S16-051-A1 Purchasing Agent No. 17-94, and SS-S16-051-A2 Purchasing Agent No. 17-109A1 are to remain in full force and effect.
