



AB2588 Air Toxics “Hot Spots” Program Annual Report for 2023

Summary

The Air Toxics “Hot Spots” Information and Assessment Act of 1987 (AB 2588) is a State of California public right-to-know law requiring local air quality management and air pollution control districts to collect information about the location, type, and quantity of toxic air contaminants (TACs) emitted into the air.

This annual report is published to provide the public with information regarding the AB 2588 Program at the Mendocino County Air Quality Management District (MCAQMD). California Health & Safety Code (HSC) Sections 44300-44394 require the California Air Resources Board (CARB) and local air districts to implement the “Hot Spots” Program. This report describes the current reporting and evaluation status for the Mendocino County Air Quality Management District permitted facilities consistent with these requirements.

The goals of the AB 2588 Program are to collect emissions data, to identify facilities having localized impacts, to ascertain health risks, and to notify nearby residents of the significance of potential health risks. The AB 2588 Program requires certain emitters of airborne toxic compounds to submit toxic emissions inventory reports and updates. Facilities meeting certain criteria must also complete health risk assessments.

This report covers facilities permitted by Mendocino County Air Quality Management District (MCAQMD) during calendar year 2023. It provides an update on the Regulation for the Reporting of Toxic Air Contaminants¹ (TACs) adopted by the California Air Resources Board, effective January 1, 2022. Consistent with AB2588 requirements, only emissions from stationary sources are evaluated.

MCAQMD currently has approximately 280 active permits which are subject to AB2588 reporting. All facilities were either “Low” or “Medium” priority. A formal health risk assessment (HRA) is not required for facilities in these two categories. A refined health risk assessment must be prepared by any facility that is ranked as “High” priority.

I. Scope of Air Toxics “Hot Spots” Program

The AB 2588 Program established a process to compile an inventory of air toxics emissions from specified facilities within each air district. The goal of the program is to assess the potential risks to public health from exposure to toxic air contaminants. AB 2588 specifies activities that the CARB, the Office of Environmental Health Hazard Assessment (OEHHA) and the districts must carry out to implement the Act.

The overall goal of the program is to reduce the release of toxic air contaminants (TACs) within each District. This goal is achieved by:

- Preparing an inventory of TACs in each District
- Quantify health risks from exposure to these compounds
- Notify the public in cases where significant health risks are projected
- Mitigate the release of TACs from facilities with high emissions

The main sources of TACs in Mendocino County are:

- Boilers
- Crematories
- Emergency diesel fueled electric generators
- Gas stations
- Mining and mineral processing facilities
- Autobody and other facilities using paints and solvents

The current report is for permitted facilities for calendar year 2023. This report will be updated annually consistent with the AB2588 requirements. The annual report quantifies 3 types of public health risks from exposure to TACs:

- Cancer Risk
- Chronic Non-Cancer Risk
- Acute Non-Cancer Risk

These risks are reported as a prioritization score.

II. The District Risk Prioritization Procedure

The District reviews the permit to operate for each facility and calculates the emission rates for various toxic air contaminants. The specific methodology is summarized on the next page.

The risk prioritization score is calculated consistent with AB2588 and OEHHA Guidelines. The District used the prioritization calculator developed by the San Joaquin Valley Air Pollution Control District³ to calculate the risk prioritization score for each facility. This calculator is based on the recommendations by the California Air Pollution Control Officers Association (CAPCOA) for calculating a facility's risk score.

The risk prioritization score by its very nature is a conservative overestimate of potential health risk. This score depends solely on the annual and hourly emission rates of various TACs and the distance from the facility to nearest home. This procedure does not take into account the local weather, terrain and other factors that can significantly influence the actual health risks to the public.

The following thresholds are used to rank a facility’s potential health risk impact:

Facility Prioritization Score (S)	Facility Description
$S \geq 25$	High Priority
$1 \geq S \leq 25$	Intermediate Priority
$S < 1$	Low Priority

III. Results of Facility Prioritization

Based on data for 2023 data reported by each facility, the risk prioritization scores are summarized below.

Priority Score	Number of Facilities
Low	231
Intermediate	49
High	0

The detailed facility list is provided in Table 1 and is based on data provided by each permitted facility. Scores below 0.001 are reported a “< 0.001”.

Facilities with a cancer prioritization score of zero (0) indicate that either the facility was inactive or there was not sufficient information available to assign the score. None of these facilities are expected to be in the “High Priority” category. This report will be updated annually.
