AMENDMENT NUMBER THREE TO DEPARTMENT OF TRANSPORTATION AGREEMENT NUMBER 200084 WITH EEGER BEEVER TREE SERVICE, INC., FOR VEGETATION MANAGEMENT SERVICES FOR CASPAR LANDFILL (CASPAR AREA)

This Amendment Number Three to Department of Transportation (DOT) Agreement Number (No.) 200084 is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Eeger Beever Tree Service, Inc., a California Corporation, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, DOT Agreement No. 200084 was entered into on June 8, 2021, for vegetation management services for Caspar Landfill; and

WHEREAS, Amendment Number One to DOT Agreement No. 200084 (Purchasing Agent Agreement No. 22-60) was entered into on April 29, 2022; and

WHEREAS, Amendment Number Two to DOT Agreement No. 200084 (BOS Agreement No. 23-112) was entered into on June 20, 2023; and

WHEREAS, upon execution of this document by the Chair on the Mendocino County Board of Supervisors and Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the compensation payable under the Agreement by \$22,400, for a new not-to-exceed amount of \$89,600.

NOW, THEREFORE, we agree as follows:

1. The total contract amount set out in Agreement No. 200084 is hereby increased from \$67,200 to \$89,600.

All other terms and conditions of DOT Agreement No. 200084 shall remain in full force and effect.
