RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS ESTABLISHING THE TOTAL MILEAGE OF COUNTY MAINTAINED ROADS AT 1,017.12 AS OF DECEMBER 31, 2024 (COUNTY WIDE)

WHEREAS, Section 2121 of the California Streets and Highways Code provides that in May of each year, each county shall submit to the California Department of Transportation (Caltrans) any additions to, or deletions from, its mileage of county maintained roads specifying the termini and mileage of each route added or excluded; and

WHEREAS, on March 26, 2024, Caltrans certified to the State Controller that the total mileage of County Maintained Roads in Mendocino County was 1,017.05 miles as of December 31, 2023; and

WHEREAS, Feed Lot Lane, County Road 250B, was extended by approximately 361 feet, which resulted in an increase of 0.07 miles in the total mileage of County Maintained Roads during the year ending December 31, 2024.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby establishes the total mileage of County Maintained Roads, as of December 31, 2024, to be 1,017.12 miles, and authorizes the Department of Transportation to transmit this Resolution to Caltrans.
