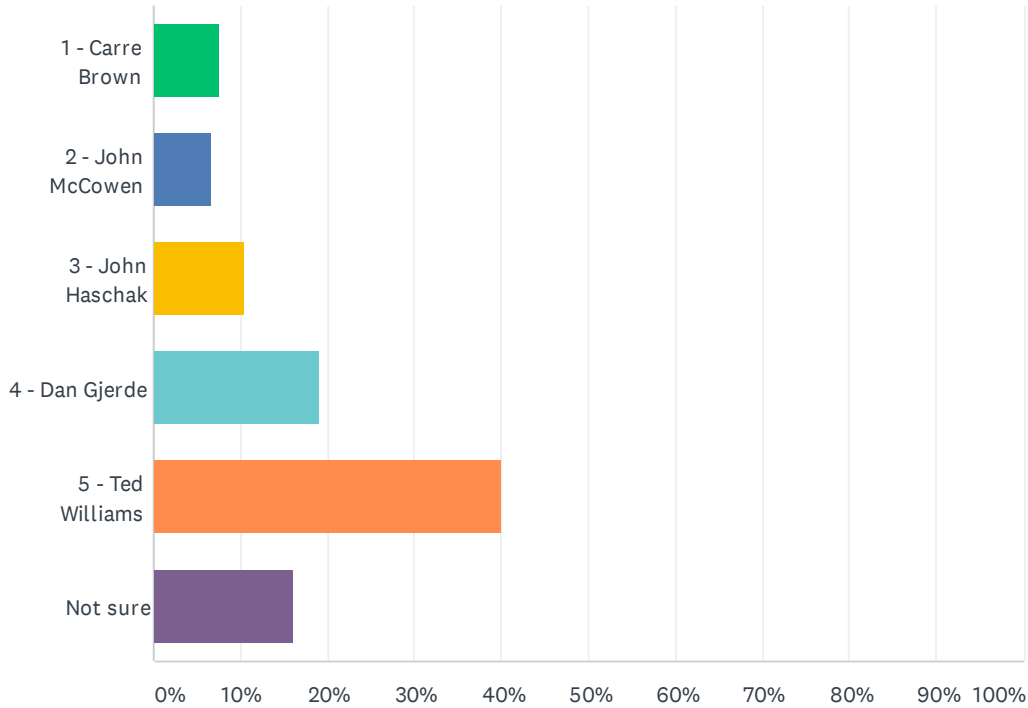

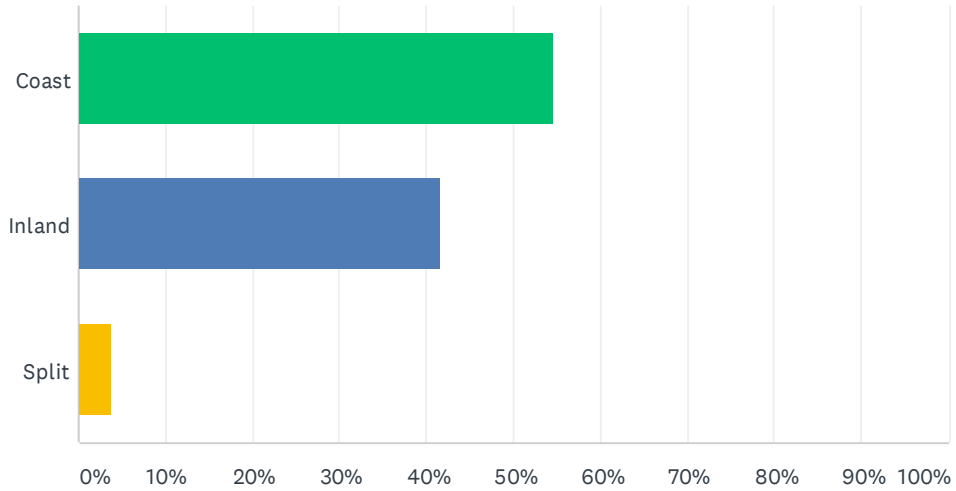

Q2 Inland or coast? (daily association for school, work, shopping)

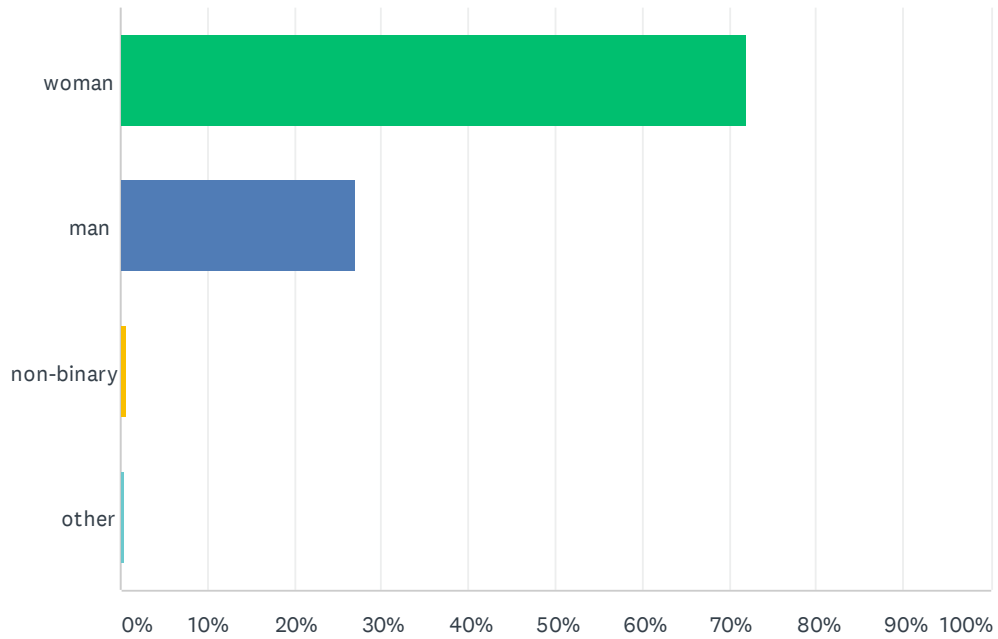

Q3 What is your gender?

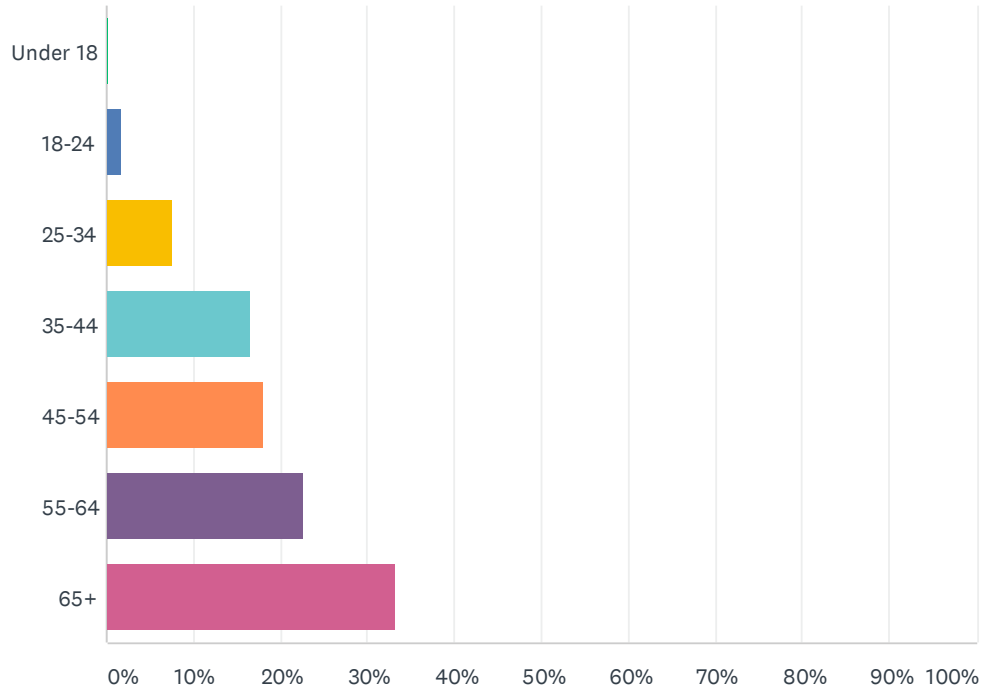

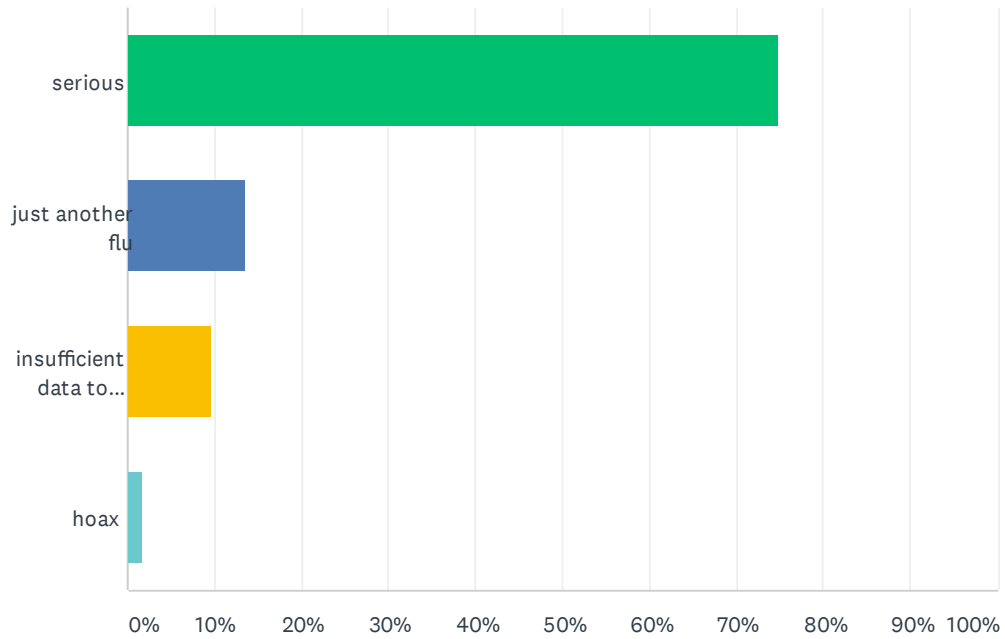

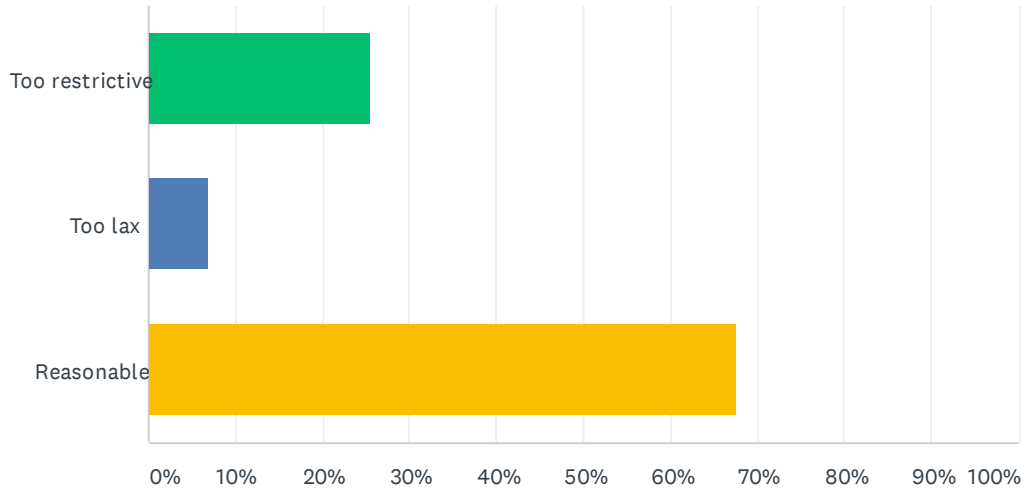

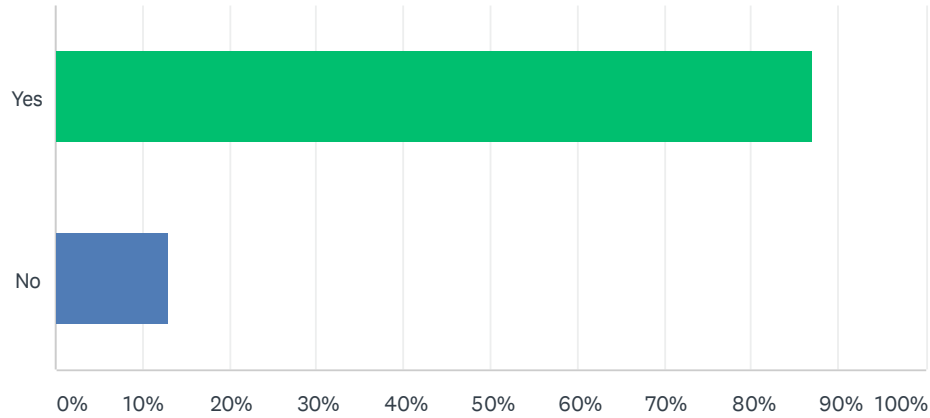

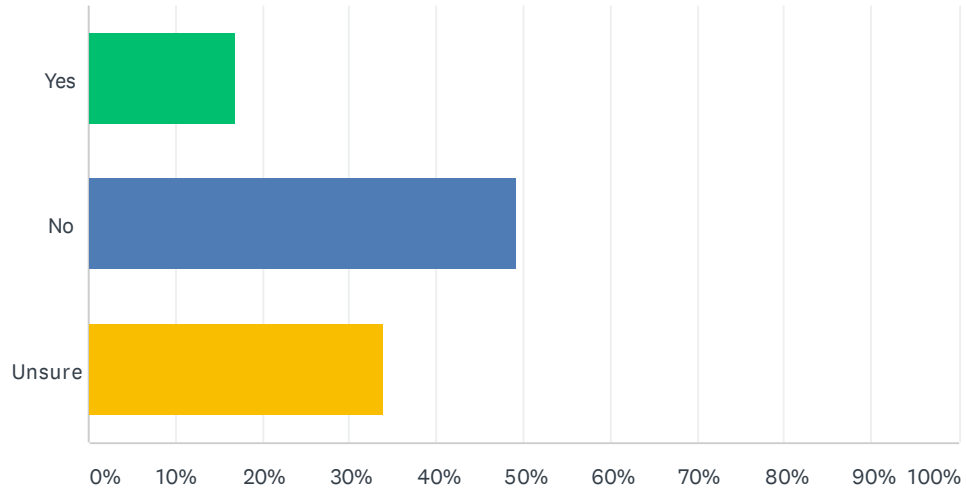

Q8 Do you anticipate life returning to normal by the new year?

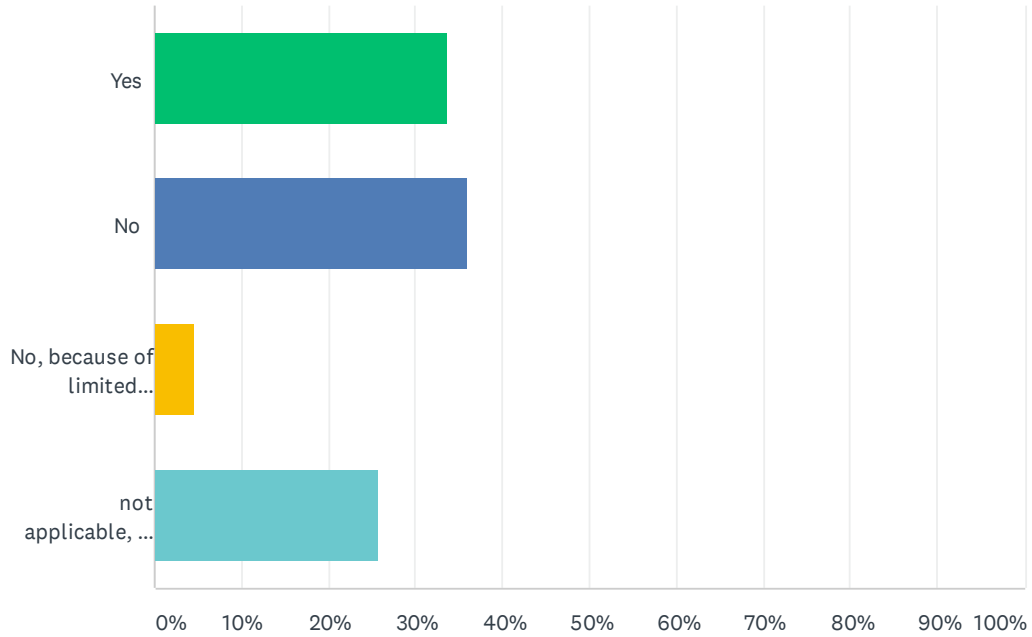

Q9 Are you able to work from home?

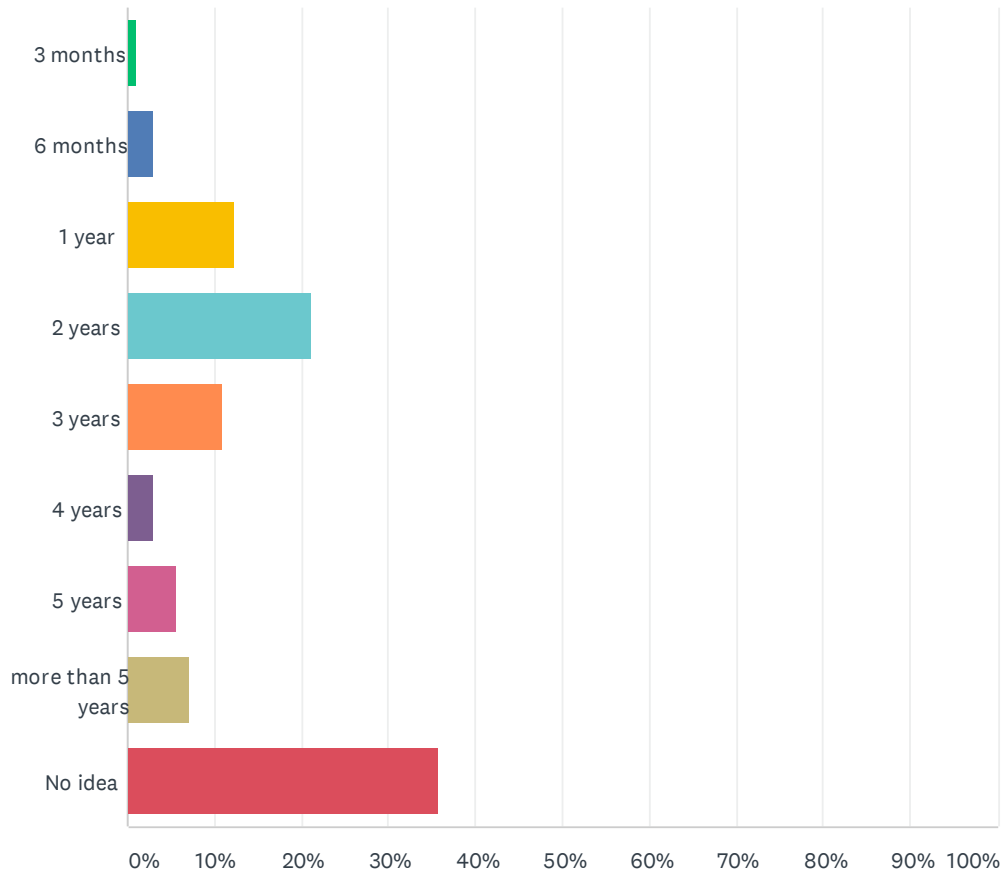

Q10 When will the local economy recover?

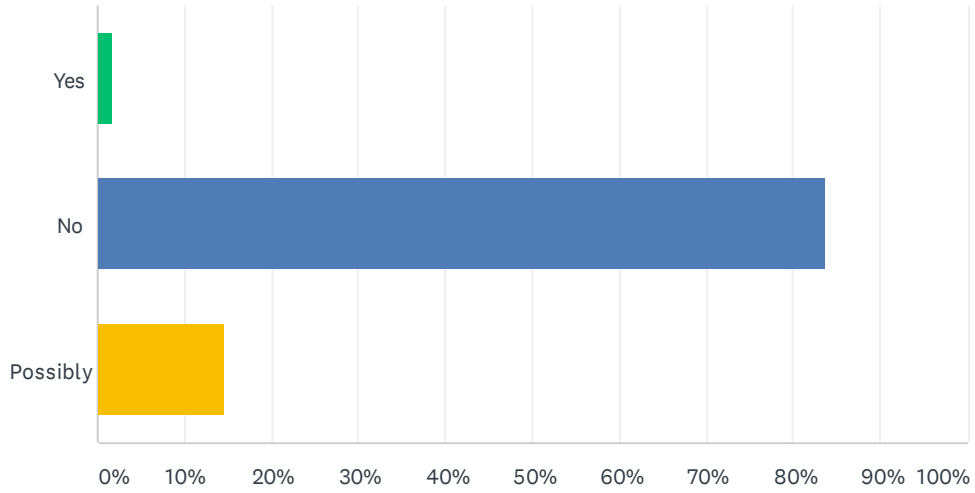

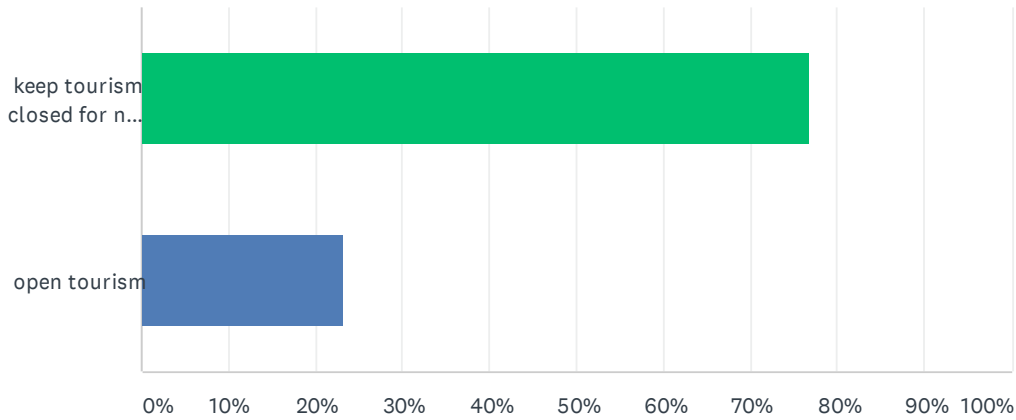

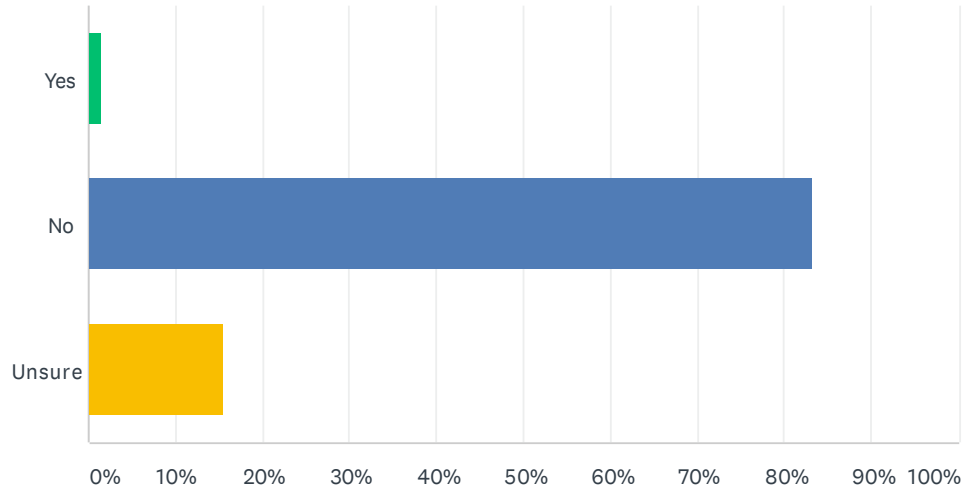

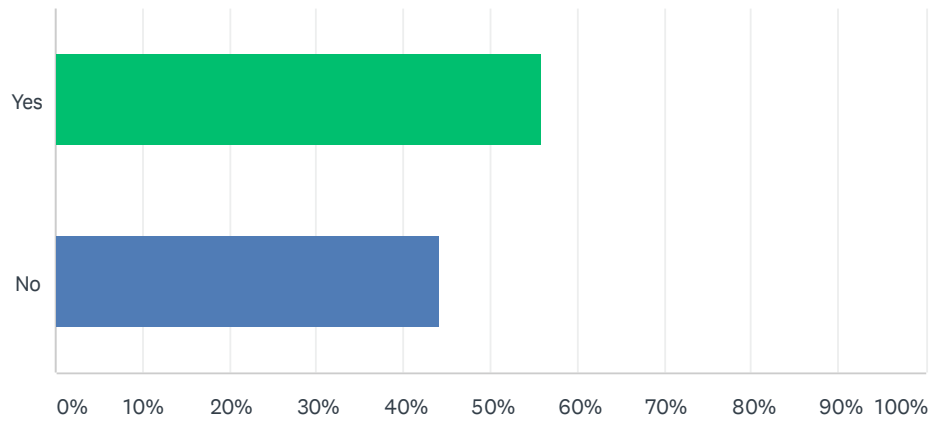

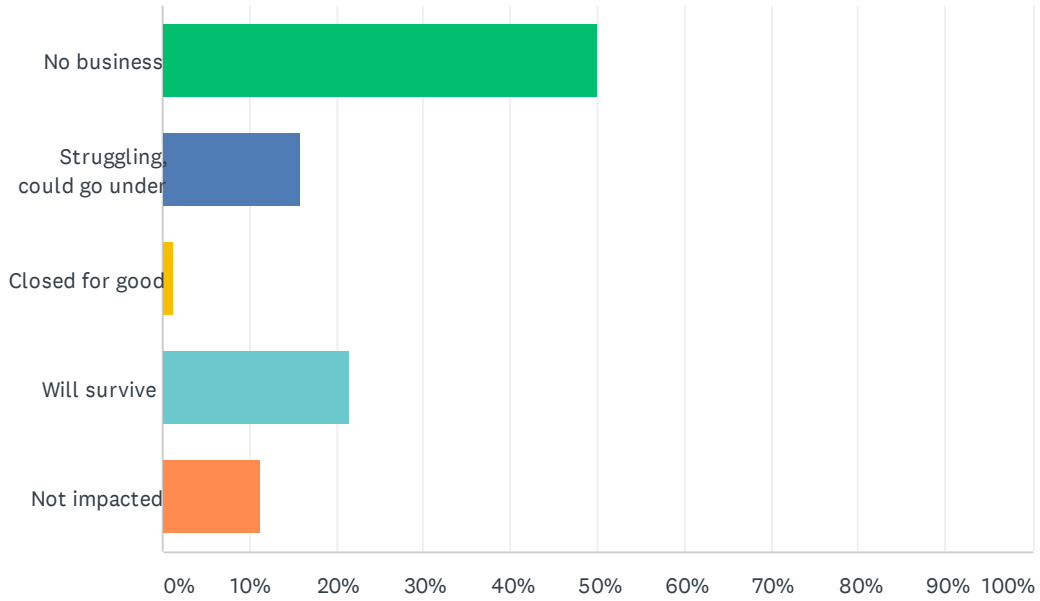

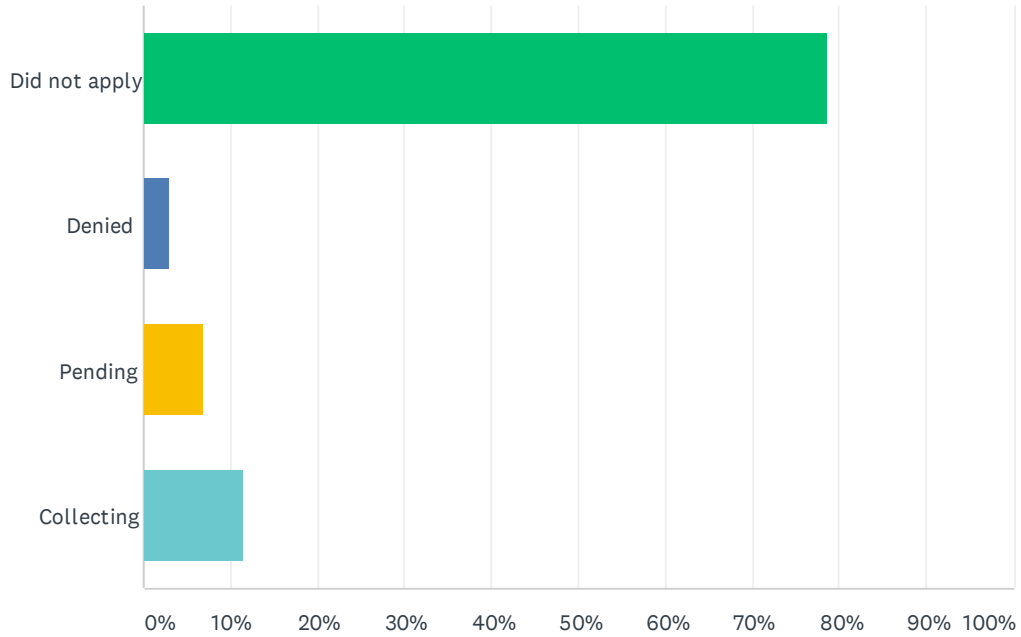

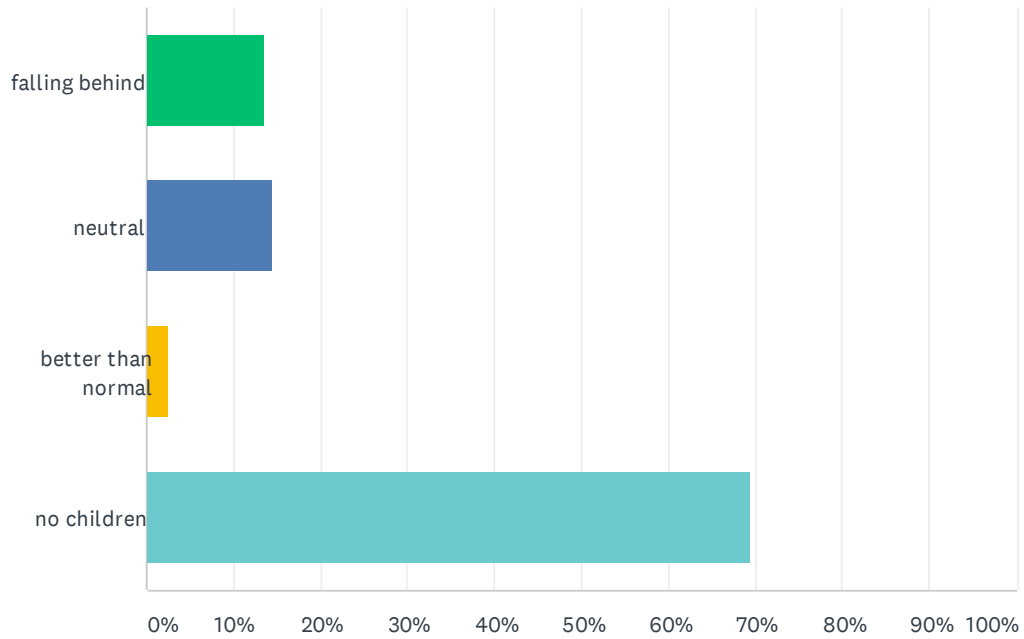

Q18 If you have school aged children, is modified education working?

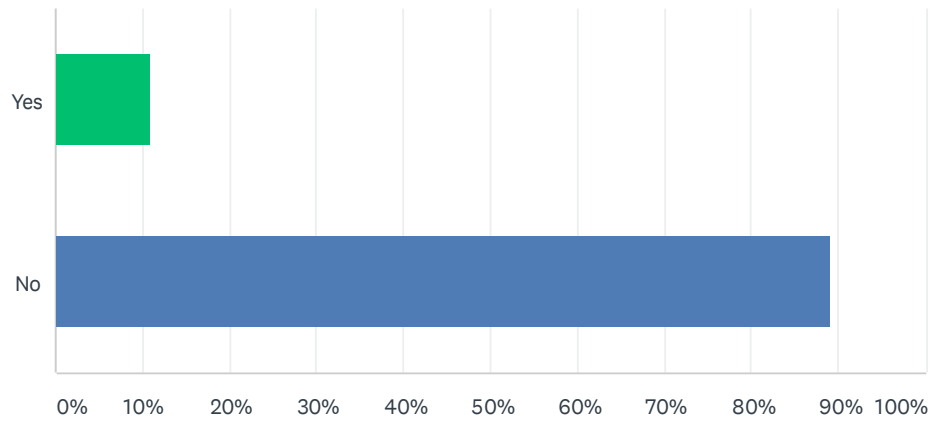

Q19 Since Shelter-in-Place started, at any time did you ever eat less than you felt you should because there wasn't enough money for food?

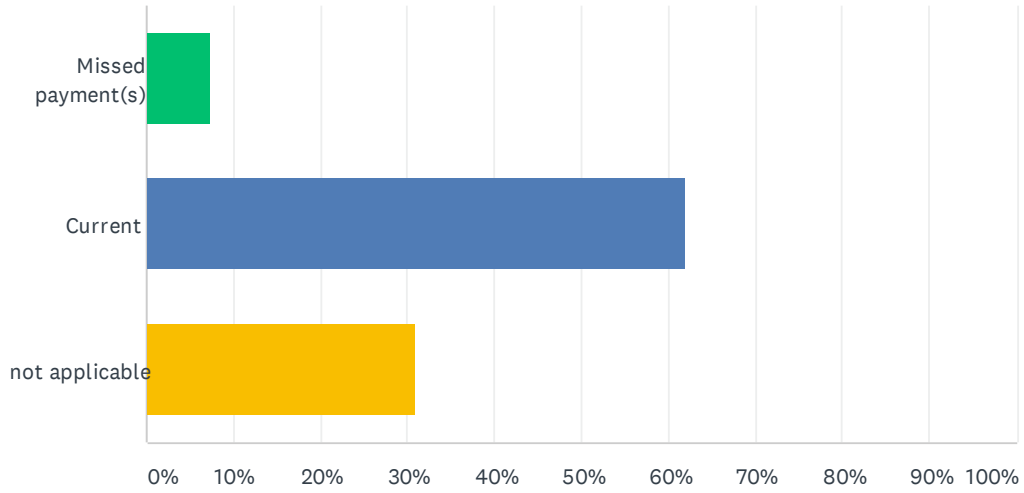

Q20 Residential rent/mortgage during COVID-19?

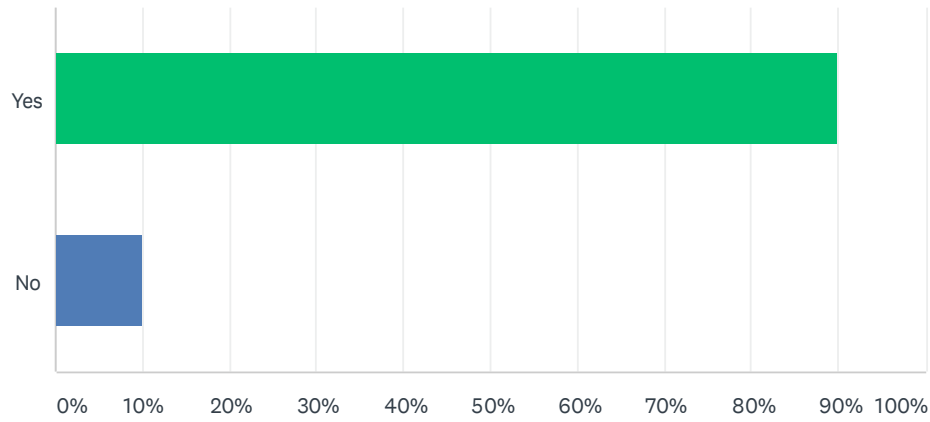

Q21 Do you understand current health orders?

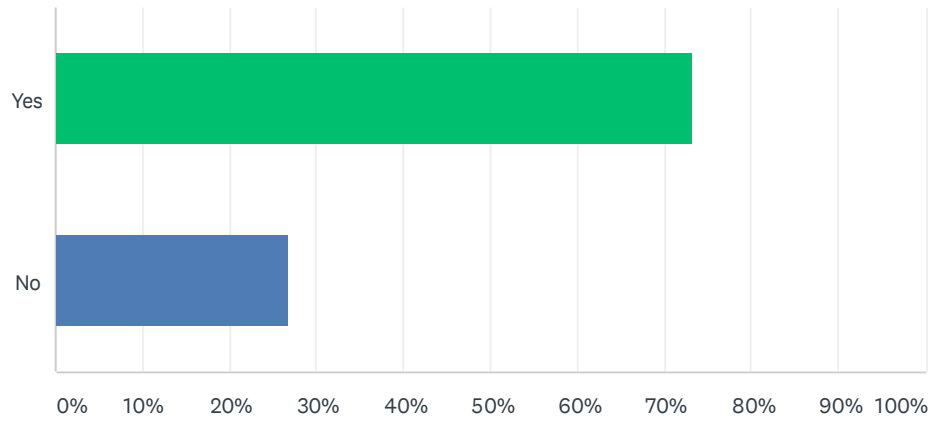

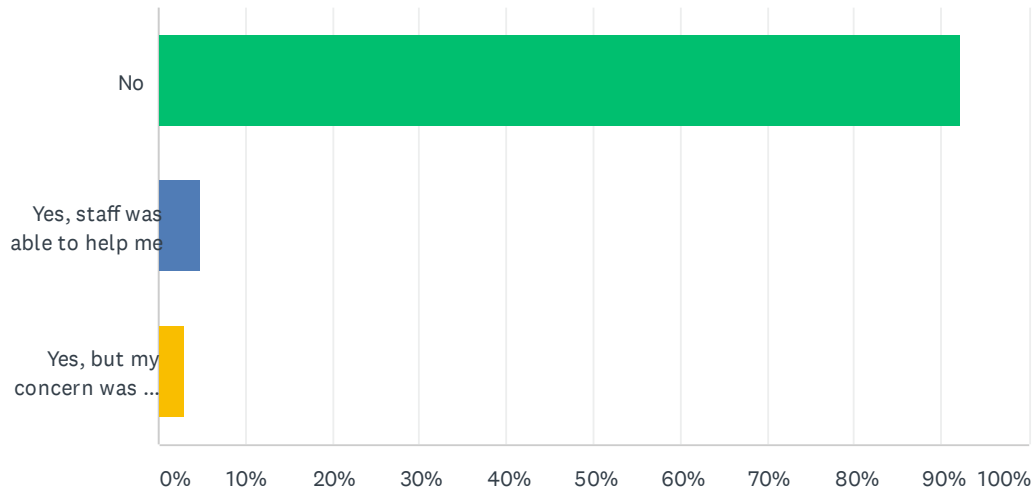

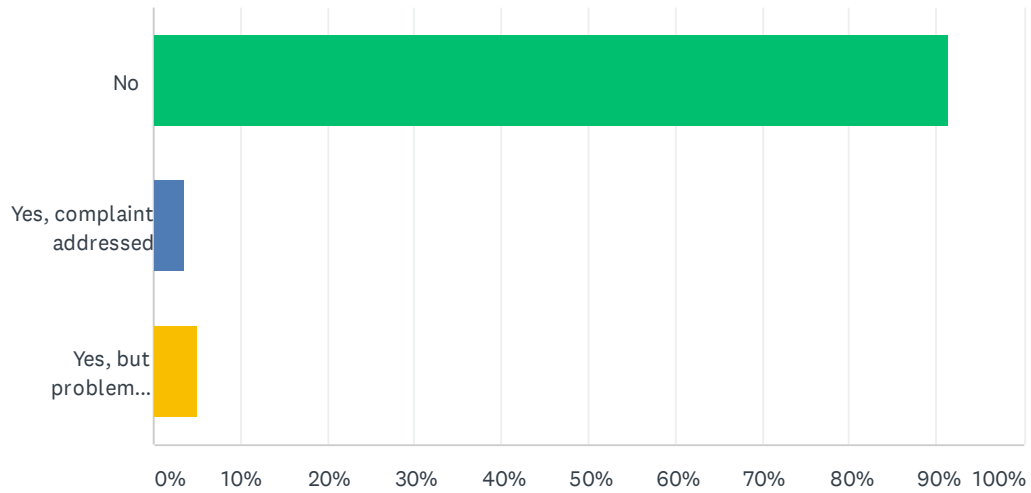

Q24 Have you raised any specific complaints to Code Enforcement?

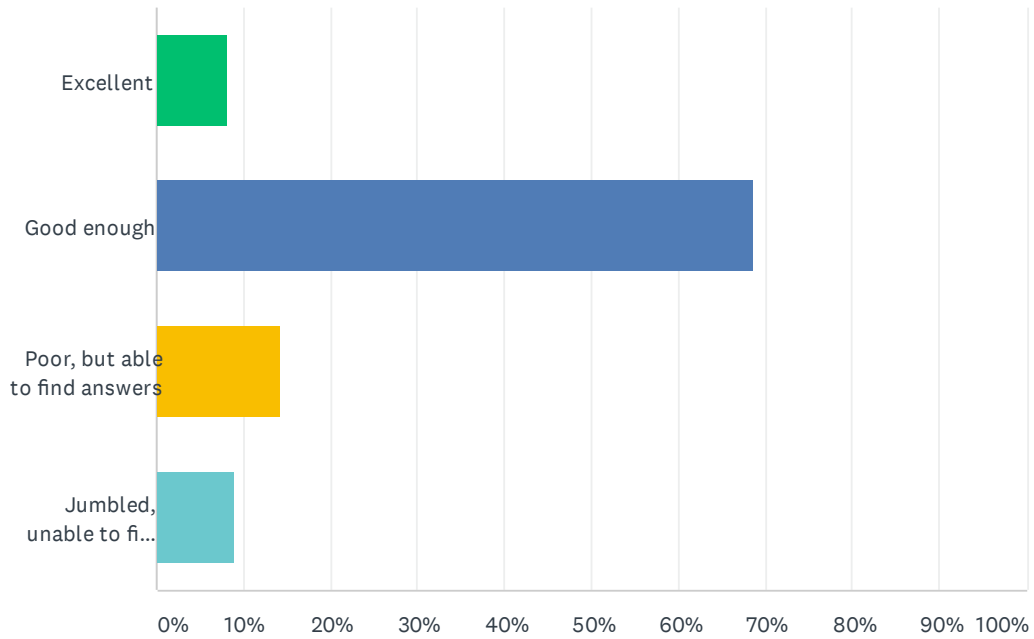

Q25 How do you find the County's COVID-19 website?

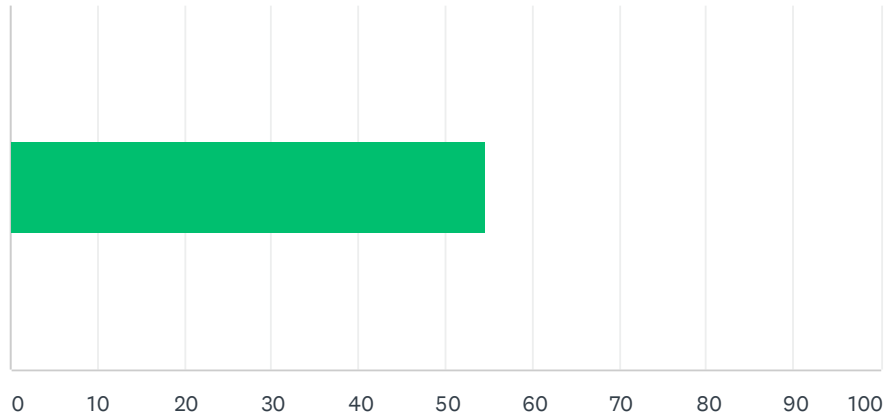

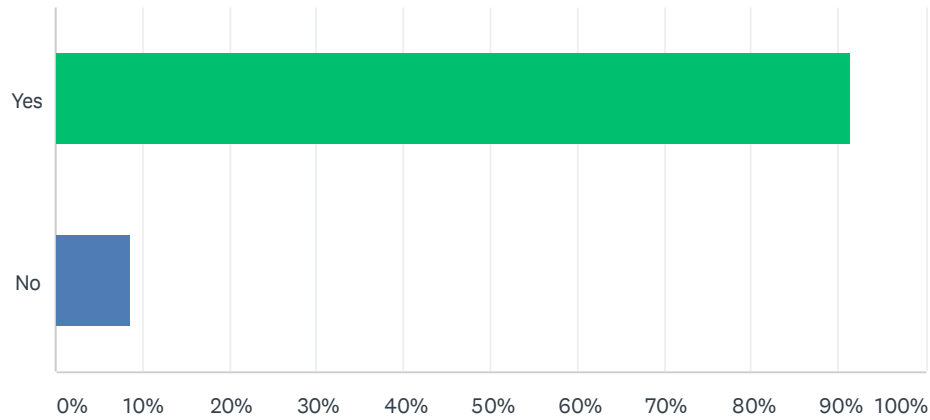

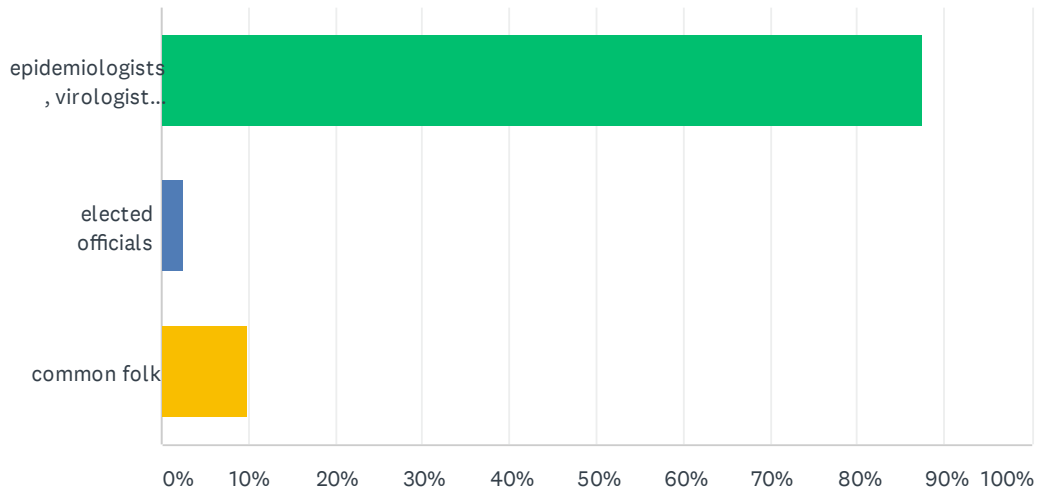
