

**NOTICE OF INTENT TO ADOPT A  
NEGATIVE DECLARATION AND  
ADDENDUM FOR THE PROPOSED  
MENDOCINO COUNTY JAIL  
EXPANSION PROJECT**

Notice is hereby provided, pursuant to Section 15072 of the California Environmental Quality Act Guidelines, that Mendocino County proposes the adoption of a Negative Declaration and an Addendum thereto for the Mendocino County Jail Expansion Project.

The Initial Study, Negative Declaration and Addendum and supporting attachments are available for review by the general public at the office of the Mendocino County Sheriff's Office, 951 Low Gap Road, Ukiah, California, 95482, and at the following website: [www.mendocinosheriff.com](http://www.mendocinosheriff.com).

The proposed Negative Declaration and Addendum will undergo a 30-day public review period during which time comments will be received, starting June 8, 2018, and ending July 9, 2018.

The Board of Supervisors will consider the adoption of the Negative Declaration at its regular meeting on July 10, 2018, at 9:00 a.m., in the Board of Supervisors Chambers, 501 Low Gap Road, Ukiah, California.

**PROJECT LOCATION:** The Mendocino County Jail is located at 951 Low Gap Road in Ukiah, California, approximately 500+/- feet east of the intersection of Low Gap Road and Despina Drive, within the City of Ukiah, and currently consists of two buildings. The proposed project would add a new single-story building on County-owned land immediately east of the existing jail complex, on property that is currently the site of the County Facilities and Fleet parking area.

**PROJECT DESCRIPTION:** The proposed building will consist of a single-story building of approximately 23,195 square feet, that will include a housing unit and a visitor center. The housing unit will include 60 rated beds expandable to 90; a safety cell, respiratory isolation cell, recreation yards, housing unit control; nursing station; medical exam room; dental exam room; program/group rooms and staff support space. The new public visiting center will include contact and non-contact visiting rooms for families and attorneys. The project will include, but is not limited to, electrical;

plumbing; mechanical; heating; ventilation, and air conditioning; security; site improvements, fire protection systems; security fencing and all other necessary appurtenances.

The Board of Supervisors' action shall be final. Any court challenge to the project may be limited to those issues raised in written correspondence delivered to the Clerk of the Board of Supervisors prior to the date of adoption of the Negative Declaration and Addendum.
