# Side Letter of Agreement between the County of Mendocino and Service Employees' International Union, Local 1021 November 29, 2022

## **Background**

Whereas Mendocino County (County) and Service Employees' International Union, Local 1021 (SEIU) are parties to a memorandum of understanding (MOU) that expired on June 30, 2022;

Whereas the parties have been engaged in good faith bargaining for a successor MOU since Spring 2022;

Whereas the parties have reached a tentative agreement on a successor MOU, but that MOU has yet to be ratified by either party;

Whereas the County and SEIU agree that County employees who are SEIU bargaining unit members should receive the benefits agreed upon by the parties during this round of negotiations as quickly as possible;

Therefore, the parties agree as follows:

- 1. On a non-precedential basis, the Board of Supervisors and SEIU agree that the County will issue the benefits set forth within this side letter of agreement.
- The parties will continue to proceed with ratification procedures for the successor MOU.

Employment terms authorized by this side letter:

#### **One-time ARPA Funds**

All regular full-time and part-time SEIU employees employed as of November 30, 2022, and also employed on the payment date will receive a \$3,000 supplemental payment from one-time ARPA funds. Extra Help employees employed between July 1, 2022 -November 26, 2022 (Measurement Period), and also employed on the payment date will receive the following based upon the average hours worked by such employee in each pay period during the Measurement Period:

- \$1500 for employees who worked an average of between 20-47 hours per pay period:
- or \$3000 for employees who worked an average of 48 or more hours per pay period.
