**AMENDMENT TO COUNTY OF MENDOCINO
AGREEMENT NO. PA-23-112**

This Amendment to Agreement No. PA-23-112 is entered into by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and **Granicus, LLC.**, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. PA-23-112 was entered into on July 1, 2023 (the "Initial Agreement"); and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date from June 30, 2025 to June 30, 2026; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total amount payable by \$19,584.49 from \$34,138.10 to \$53,722.59; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to add a new Order Form budget for the period of July 1, 2025 through June 30 2026.


NOW, THEREFORE, we agree as follows:

1. An Order Form to continue the services for the period July 1, 2025, through June 30, 2026, is attached hereto and hereby added to the Initial Agreement.
2. Pursuant to Paragraph 3a) of the Initial Agreement, by adding the Order Form to the Initial Agreement, the termination date is hereby extended to June 30, 2026.
3. Pursuant to Paragraph 4a) of the Initial Agreement, by adding the Order Form to the Initial Agreement, the contract amount is hereby increased by \$19,584.49 from \$34,138.10, for a new total contracted amount of \$53,722.59.

All other terms and conditions of the Initial Agreement shall remain in full force and effect.
