## AMENDMENT TO COUNTY OF MENDOCINO AGREEMENT NO. BOS 24-010

This Amendment to Agreement No. <u>BOS 24-010</u> is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and <u>DAVID J. RAPPORT, ATTORNEY AT LAW</u>, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. BOS 24-010 was entered into on January 23, 2024; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date set out in Agreement No. <u>BOS 24-010</u>, from <u>July 1, 2024</u> to <u>June 30, 2025</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to add the amount of Ten Thousand Dollars (\$10,000) for Fiscal Year 2024/2025, for a revised total Agreement amount of Twenty Thousand Dollars (20,000).

## NOW, THEREFORE, we agree as follows:

- The termination date set out in Agreement No. <u>BOS 24-010</u> is hereby extended from <u>July 1, 2024</u> to <u>June 30, 2025</u>, <u>subject to the right of the COUNTY or the CONTRACTOR to terminate the agreement by written notice of termination prior to June 30, 2025</u>.
- 2. The total contracted amount set out in Agreement No. <u>BOS 24-010</u> is hereby increased from \$10,000 to \$20,000.

All other terms and conditions of Agreement No. <u>BOS 24-010</u> shall remain in full force and effect.
