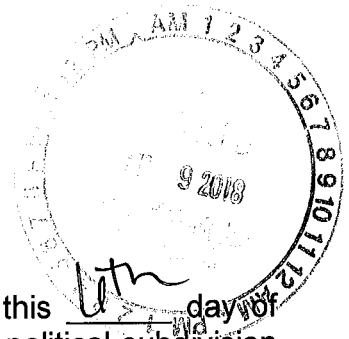


**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 17-100**



This Amendment to BOS Agreement No. 17-100 is entered into this 9th day of Feb., 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Cobblestone Systems Corp., hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 17-100 was entered into on September 12, 2017; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Cobblestone Systems Corp., this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, the COUNTY has determined that it should switch from "Named User" licenses to "Concurrent User" licenses, as listed in Exhibit A.

NOW, THEREFORE, we agree as follows:

1. Exhibit A of BOS Agreement No. 17-100 has been altered to reflect the change from "Named User" licenses to "Concurrent User" licenses. Exhibit A, attached to this amendment, shall supersede any previous Exhibit A.

All other terms and conditions of BOS Agreement No. 17-100 shall remain in full force and effect.
