

RESOLUTION NO. 21-072

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AMENDING THE POSITION ALLOCATION TABLE PROVIDING THE NUMBER AND COMPENSATION OF OFFICERS, DEPUTIES AND EMPLOYEES IN THE VARIOUS OFFICES OF THE COUNTY OF MENDOCINO

WHEREAS, the Board of Supervisors has adopted Resolution No. 20-079 which sets forth the classifications, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the wish and desire of the Board of Supervisors to amend said resolution to meet the needs of County service; and

WHEREAS, the affected departments or agencies have agreed to incorporate the positions within their existing fiscal year budgets; and

WHEREAS, the Civil Service Commission approved the new classification of Benefits Technician, the abolishment of the classification of Benefits Specialist, and the reclassification of incumbent Benefits Specialist to Benefits Technician at its April 19, 2021 meeting; and

WHEREAS, the pay of Benefits Technician has been aligned with Human Resources Technician, effective July 11, 2021, the Benefits Technician shall receive a pay adjustment in the amount necessary to maintain the alignment with Human Resources Technician.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby adopts the below actions and authorizes the Position Allocation Table of Resolution No. 20-079 to be amended accordingly:
