Re: Bureau of Justice Assistance Body-Worn Camera Policy and Implementation Program to Support Law Enforcement Agencies

Dear Darcie,

The Bureau of Justice Assistance (BJA) recently solicited funding for a Body-Worn Camera Policy and Implementation Program to Support Law Enforcement Agencies. This Federal grant opportunity provides up to a fifty percent match for the purchase of body-worn cameras (BWCs) to establish, expand, or enhance a comprehensive BWC program and to use BWC footage to enhance officer training or constitutional policing practices. The filing deadline for the application is July 15, 2024.

MCSO's grant application will include a \$30,000 request for funding equal to approximately half the cost of deploying 30 Body Worn Cameras to Corrections staff in the new behavioral health wing of the Jail once construction is completed. The application for this solicitation is currently being prepared and we do not have time to submit it for Board approval prior to the deadline.

Under County Policy #25, if there is a time restriction limiting the Department/Office from taking the item before the Board, the CEO may approve a waiver allowing the application to proceed provided the application item is agendaized at the next available Board meeting.

I am respectfully requesting your approval for my signature on the grant application so that we may meet the deadline and be a candidate for the award.
