

**RESOLUTION NO. 22-209**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING SUBMISSION OF GRANT APPLICATION FOR AND ACCEPTANCE OF THE CALIFORNIA DEPARTMENT OF PUBLIC HEALTH, CENTERS FOR DISEASE CONTROL AND PREVENTION CRISIS RESPONSE: COVID-19 PUBLIC WORKFORCE AND IMMUNIZATION CHAMPIONS PROGRAM FUNDS; AND AUTHORIZING THE MENDOCINO COUNTY PUBLIC HEALTH DIRECTOR TO SIGN THE RESULTING ALLOCATION AGREEMENT UP TO \$117,300**

WHEREAS, The Mendocino County Board of Supervisors approves submission of grant application for the California Department of Public Health, Centers for Disease and Prevention (CDC) Crisis Response: COVID-19 Public Workforce and Immunization Champions Program funds, and authorizes the Mendocino County Public Health Director to sign the resulting Allocation Agreement, up to \$117,300; and

WHEREAS, the Mendocino County Public Health Department will route the California Department of Public Health CDC Crisis Response: COVID-19 Public Workforce and Immunization Champions Program Allocation Agreement through the standard County process including Chief Executive Office, County Counsel and Risk Management reviews; and

WHEREAS, the California Department of Public Health CDC Crisis Response: COVID-19 Public Workforce and Immunization Champions Program will benefit the County and its residents; and

WHEREAS, applying for the California Department of Public Health CDC Crisis Response: COVID-19 Public Workforce and Immunization Champions Program funding is in the best interest of the County.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors approves submission of grant application and authorizes the Mendocino County Public Health Director to sign the resulting Allocation Agreement, up to \$117,300, and any Amendments that do not exceed the maximum amount.
