

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 21-167**

This Amendment to BOS Agreement No. 21-167 is entered into this 20th day of 2023, 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and INTERWEST, hereinafter referred to as "CONTRACTOR".
