

## RESOLUTION NO. 21-075

### **RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING DEPARTMENT OF TRANSPORTATION TO AWARD, FOR AN AMOUNT GREATER THAN PREVIOUSLY AUTHORIZED, DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 200098, TO INCLUDE BID ADDITIVE 3, TO PERFORM A 2021 CORRECTIVE/PREVENTATIVE MAINTENANCE PROJECT ON ORR SPRINGS ROAD, COUNTY ROAD 223, MILEPOST 36.00 TO 37.11 (UKIAH AREA)**

WHEREAS, the Mendocino County Department of Transportation (DOT) desires to provide road maintenance by applying a Full Depth Reclamation followed by a Double Chip Seal wearing course on Orr Springs Road, County Road (CR) 223 between Milepost (M.P.) 24.25 and MP 37.11; and

WHEREAS, the cost of the 2021 Corrective/Preventative Maintenance Project on Orr Springs Road is anticipated to be paid 100% by available Road Maintenance and Rehabilitation Account (RMRA) funds; and

WHEREAS, this project will be completed to provide the maintenance required to improve and extend the usefulness of our roads; and

WHEREAS, funding to accommodate construction costs is available in Budget Unit 3041 for Fiscal Year (FY) 2020/21 and FY 2021/22; and

WHEREAS, by Resolution Number (No.) 21-039, the Board of Supervisors authorized DOT to advertise for bids and award DOT Contract No. 200098, in the estimated amount of \$4,000,000; and

WHEREAS, the base bid of DOT Contract No. 200098 provided for work from M.P. 24.25 to 34.00, with bid additive 1 extending the work from M.P. 34.00 to 35.00, bid additive 2 extending the work from M.P. 35.00 to 36.00, and bid additive 3 extending the work from M.P. 36.00 to 37.11, depending on bid amounts and funding availability; and

WHEREAS, the lowest responsive, responsible bidder was Northwest Paving, Inc., with a base bid of \$2,964,604.50; and

WHEREAS, DOT has awarded DOT Contract No. 200098 in the amount of \$3,631,883.10 for the base bid plus bid additives 1 and 2, to perform the 2021 Corrective Preventative Maintenance Project on Orr Springs Road, County Road (CR) 223 between milepost (M.P.) 24.25 and 36.00; and

WHEREAS, the amount for bid additive 3 is \$375,789.90, which would bring the contract total for the base bid plus bid additives 1, 2, and 3 to \$4,007,673.00; and

WHEREAS, the Director of Transportation recommends that the Board of Supervisors authorize a total contract amount of \$4,007,673.00 for DOT Contract No. 200098, so as to allow for the award of Bid Additive 3 in the amount of \$375,789.90; and

WHEREAS, under Section 20142 of the California Public Contract Code, the Board of Supervisors may authorize the Director of Transportation to execute contract change orders subject to certain cost limitations; and

WHEREAS, by Resolution Number (No.) 07-009, the Board of Supervisors authorized the Director of Transportation to execute changes to any DOT contract that exceeds \$250,000 by up to \$25,000, plus 5% of the amount of the original contract costs in excess of \$250,000 and in no event shall any change order or alteration exceed \$150,000.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Authorizes and directs the Director of Transportation to award DOT Contract No. 200098 Bid Additive 3 in the amount of \$375,789.90 for a total contract amount of \$4,007,673.00, for the 2021 Corrective/Preventative Maintenance Project on Orr Springs Road, CR 223, between M.P. 36.00 and M.P. 37.11.
