

COVID-19 RELIEF PROGRAM IMPACT REPORT

GRATITUDE

As we bring our COVID-19 Relief Program to a close, we wish to express our sincere gratitude to the many donors who made this work possible. As we look back, we are so thankful for the many donors and nonprofits who showed up for the community during this crisis, and we are pleased to share the impact made over two years.

OVERVIEW

In March 2020, when the shelter-in-place order began, the Community Foundation of Mendocino County launched our COVID-19 Relief Program to support individuals, families, and nonprofits impacted by the pandemic. Our goal was to address the immediate needs of our community while taking a long-term approach to providing support. With the help of our donors, the relief program has offered much-needed financial assistance for two years. We have just awarded our final round of funding to alleviate the immediate impacts of the pandemic through individual assistance, hunger relief, nonprofit relief, and student relief grants.

INDIVIDUAL ASSISTANCE: \$937,000

The individual assistance program was designed to provide rental assistance, utility assistance, basic needs, groceries, and emergency financial aid to those most impacted by the pandemic. We made grants totaling \$937,000 to eight organizations to ensure access to these services across the county: Anderson Valley Health Center, Conception Coast Project (i.e., COVID Response Network), Laytonville Healthy Start Family Resource Center, MCOE Foster and Homeless Youth Services Program, Mendocino Coast Children's Fund, Mendonoma Health Alliance, North Coast Opportunities, and Round Valley Indian Health Center. Your support allowed us to ensure the most vulnerable populations in our community remained housed and fed during the pandemic.

TOTAL GRANTED

The Community Foundation of Mendocino County has taken a multi-sector approach providing COVID-19 Relief Funding to individuals and nonprofits. Since launching the program we have awarded just over \$3.3M in relief.

INDIVIDUAL ASSISTANCE

Providing rent and utility assistance, gas cards, and groceries for individuals and families impacted by the pandemic.

NONPROFIT RELIEF

Supporting the nonprofit organizations that care for our community.

Providing funding for meals, food boxes, and grocery gift cards for individuals and families impacted by the pandemic.

Supporting scholarship recipients and Mendocino College students in need of individual assistance.

NONPROFIT RELIEF: \$603,900

The nonprofit sector provided the critical safety-net required to help our community through this crisis. With increased demand and reduced revenue, it was important to offer financial support to these organizations. Since the start of the pandemic, we have awarded \$603,900 in nonprofit relief grants to organizations countywide. Funds allowed nonprofit organizations to cover gaps in operating, pivot to respond safely, and broaden the scope of their offerings to meet the ever-changing needs.

HUNGER RELIEF: \$1,505,653

Food insecurity continues to be one of the critical issues for Mendocino County during the pandemic. Food banks and pantries across the county report increased demand for food. To help meet this demand, the Community Foundation made grants to hunger relief organizations, specifically to support food distribution countywide. Organizations included small, rural food pantries run by committed volunteers, congregate meal sites, senior centers, and our local food banks. We were able to leverage donations with FEMA/ARPA and CalFresh funds from the County of Mendocino to award \$1,505,653 in hunger relief over two years.

STUDENT RELIEF: \$54,450

The pandemic exacerbated the needs of many students and their families, making it challenging to cover the cost of food, housing, tuition, and travel. We created the Student Relief Fund to assist eligible students with one-time cash assistance to overcome obstacles that could prevent them from completing their academic program. Support was provided to 25 scholarship recipients and 387 Mendocino College students in need.

CONCLUSION

We launched this program, unsure how long support would be necessary, unaware that we would face the pandemic's impacts two years later. Our goal was to support the community through the most challenging times, and with restrictions easing, we are grateful to have made a difference for those most impacted. Since establishing our COVID-19 Relief Program, we have granted over \$3.3M. Our final round of funding was awarded in early 2022 to support individuals and nonprofits, and we have now closed the program.

Your investment was critical to the success of our relief efforts, and we thank you for all you have done to help alleviate the impacts caused by the COVID-19 pandemic.



COUNTY OF MENDOCINO HUNGER RELIEF FUNDING

TOTAL GRANTED IN HUNGER RELIEF: \$1,023,611

In collaboration with funding provided by the County of Mendocino, The Community Foundation of Mendocino County has awarded just over \$1M in hunger relief grants countywide to food banks, senior centers, congregate meal sites, and tribal entities to relieve food scarcity during the pandemic.



Over 281,831 MEALS

Provided through congregate dining sites and Meals on Wheels programs.

Over 2.215 BOXES OF FOOD

Delivered through Hopland Band of Pomo Indians, Pinoleville Pomo Nation, and MendoLake Food Hub.

Over 284,949 POUNDS OF FOOD

Delivered countywide through Mendocino Food & Nutrition Program.
