**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD FIVE DEPARTMENT OF TRANSPORTATION CONTRACTS TO CONSTRUCT 2019 STORM DAMAGE PERMANENT REPAIRS ON BRICELAND ROAD, COUNTY ROAD 435, MILEPOST 4.79; FISH ROCK ROAD, COUNTY ROAD 122, MILEPOST 17.35; GUALALA ROAD, COUNTY ROAD 501, MILEPOST 0.33; PEACHLAND ROAD, COUNTY ROAD 128, MILEPOST 1.60; AND WINDY HOLLOW ROAD, COUNTY ROAD 508, MILEPOST 2.11, AT AN ESTIMATED COST OF \$2,989,800 (COUNTYWIDE)**

WHEREAS, the Mendocino County Department of Transportation (DOT) is desirous of performing storm damage permanent repairs utilizing contractor forces on Briceland Road, County Road (CR) 435, milepost (MP) 4.79; Fish Rock Road, CR 122, MP 17.35; Gualala Road, CR 501, MP 0.33; Peachland Road, CR 128, MP 1.60; and Windy Hollow Road, CR 508, MP 2.11; and

WHEREAS, by way of Resolution Number (No.) 19-037, the Board of Supervisors declared the existence of a Local Emergency related to the February 2019 Winter Storms Event; and

WHEREAS, construction costs for these five DOT projects are currently estimated to be some \$2,989,800 and are anticipated to be 93.75% reimbursable through Federal Emergency Management Agency and California Disasters Assistance Act funding; and

WHEREAS, funding to accommodate construction costs prior to reimbursement has been budgeted through Budget Unit 3030, for Fiscal Year (FY) 2020/21 and FY 2021/22; and

WHEREAS, under Section 20395 of the California Public Contract Code, the Board of Supervisors may authorize the Director of Transportation to execute contract change orders subject to certain cost limitations; and

WHEREAS, by Resolution 07-008, the Board of Supervisors authorized the Director of Transportation to execute changes to any DOT contract that exceeds \$250,000 by up to \$25,000, plus 5% of the amount of the original contract costs in excess of \$250,000, and in no event shall any change or alteration exceed \$150,000; and

WHEREAS, the Director of Transportation recommends and requests authorization to proceed with the advertisement and award of these five DOT contracts to construct the repair of these storm damaged sites upon receiving the authorization to construct the projects from approving agencies.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Authorizes and directs the Director of Transportation to sign the Notice to Bidders, inviting bids for construction of storm damage permanent repairs on the above mentioned road segments, upon receiving the funding authorization from approving agencies to proceed with such action; and

2. Authorizes and directs the Director of Transportation to award the above mentioned DOT contracts, upon confirmation of appropriate low bidders and acceptable contract documents by County Counsel and Risk Management, and report results to the Board through the applicable Director's Report.




