

RESOLUTION NO. 21-103

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AMENDING THE POSITION ALLOCATION TABLE PROVIDING THE NUMBER AND COMPENSATION OF OFFICERS, DEPUTIES AND EMPLOYEES IN THE VARIOUS OFFICES OF THE COUNTY OF MENDOCINO

WHEREAS, the Board of Supervisors has adopted Resolution No. 21-090 which sets forth the classifications, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the desire of the Board of Supervisors to amend said resolution to meet the needs of County service; and

WHEREAS, the affected departments or agencies have agreed to incorporate the positions within their existing fiscal year budgets; and

WHEREAS, the Director General Services Agency shall receive Cost of Living Adjustment (COLA) on September 5, 2021 in accordance with Department Head Association MOU; and

WHEREAS, the Director Social Services salary is aligned to be twenty percent (20%) above the Deputy Director Social Services – Children’s, Director Social Services shall receive a salary adjustment in accordance with Department Head Association MOU on September 5, 2021 that will maintain the twenty percent (20%) alignment with Deputy Director Social Services – Children’s increase scheduled for October 4, 2021 in accordance with Management Association MOU.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby adopts the below classification and authorizes the Position Allocation Table of Resolution 21-090 to be amended as follows:




