

RESOLUTION NO. 25-125

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS ESTABLISHING THE APPROPRIATIONS LIMIT FOR SPECIAL DISTRICTS GOVERNED BY THE MENDOCINO COUNTY BOARD OF SUPERVISORS FOR FISCAL YEAR 2025-26

WHEREAS, Government Code section 7910 mandates that the governing body of each local jurisdiction establish the appropriations limit for each fiscal year by passage of a resolution; and

WHEREAS, the County Auditor-Controller has determined the appropriations limit for fiscal year 2025-26; and

WHEREAS, the documents evidencing the calculation of the fiscal year 2025-26 Gann limit have been made available to the public fifteen days prior to the scheduled and noticed meeting of the Mendocino County Board of Supervisors. Such documents were published on the website of the Mendocino County Auditor-Controller.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors that the following is adopted as the appropriations limit for the Special Districts governed by the Mendocino County Board of Supervisors for fiscal year 2025-26:

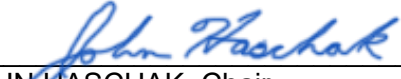
