## **RESOLUTION NO. 25-141**

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS RATIFYING THE SUBMITTAL OF THE APPLICATION FOR THE CALIFORNIA CLIMATE INVESTMENT FIRE PREVENTION GRANT PROGRAM TO THE STATE DEPARTMENT OF FORESTRY AND FIRE PROTECTION, FOR THE HOPLAND SHADED FUEL BREAK PROJECT IN THE AMOUNT NOT TO EXCEED \$939,159, AUTHORIZING THE CHIEF EXECUTIVE OFFICER TO EXECUTE THE GRANT AGREEMENT AND SUBMIT ALL DOCUMENTS IF AWARDED

WHEREAS, the Governor of the State of California in cooperation with the California State Legislature has enacted the State of California Climate Investment, which provides funds to the State of California and its political subdivision for fire prevention programs; and

WHEREAS, the State of California Department of Forestry and Fire Protection (CAL FIRE) has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing application by local agencies, non-profit organizations, and others under the Program; and

WHEREAS, the County of Mendocino will enter into an agreement with the State of California to carry out the Hopland Shaded Fuel Break Project project;

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors:

- 1. Approves the filing of an application for the "California Climate Investment Wildfire Prevention Grant Program"; and
- 2. Certifies that said applicant has or will have sufficient funds to operate and maintain the project; and
- 3. Certifies that funds under the jurisdiction of the Mendocino County Board of Supervisors are available to begin the project; and
- 4. Certifies the County of Mendocino will expend grant funds prior to February 15, 2029; and
- 5. Appoints the Chief Executive Officer, or a designee, to conduct all negotiations, execute and submit all documents including, but not limited to, applications, agreements, amendments, payment requests and so on, which may be necessary for the completion of the aforementioned project.
