**Supervisor Mulheren March 2022 update on Ad Hoc Committee Assignments**

**(Date assigned, Description, Update)**

5/25/21 (Mulheren/Gjerde) Work with county cities on tax sharing agreement

- Ad Hoc did not meet in the month of March, waiting for the Cities to coordinate meeting together, delayed due to City Manager changes and changes within the County

6/9/21 (Mulheren/Williams) Formation of an Ad Hoc Committee to work with community partners on Fire and Emergency Medical Services related issues

- Met in Anderson Valley and via Zoom to discuss possible collaboration and potential use of the CSA3 District to fund additional Fire Service resources, need to find ways to fund and facilitate ambulance services

6/22/21 (Mulheren/Williams) Formation of an Ad Hoc Committee to develop criteria for greater mental health services outcomes

Met and received final data formatting, needs to be scheduled for full Board Discussion

9/1/21 (Mulheren/McGourty) Formation of an Ad Hoc Committee to work on Parks Needs Assessment Phase II

- Presentation to the Board received, no changes in park portfolio. The Ad Hoc will continue to work on creating a sustainable parks program and bring back to the Full Board

11/30/21 (Mulheren/Gjerde) Formation of an Ad Hoc Committee to work on the CEO/CAO Ordinance development

- Item was brought forward but continued to a future agenda by Haschak and McGourty
