The County has stated several goals for the County Facilities Conceptual Strategic Plan:

- Consolidate inefficiently used spaces to maximize the use of all Facilities.
- Move County Facilities out of Leased spaces & improve County Owned Facilities.
- Develop a plan for improving deferred maintenance items.
- Remove underutilized facilities and facilities that are too costly to repair / remodel from the County's Assets.

The Facilities Conceptual Strategic Plan combines the efforts of the Space Needs Assessment and the Facility Condition Assessments to make recommendations for the County Facilities. These recommendations are broken down into three phases on the tables below, with each phase representing approximately 5 year increments. The priority of each of the projects is subjective and several of the priorities are connected to each other as well as to outside influences that may elevate their priority for the County. The most notable areas of focus are:

- 1. Emergency Operations Center (EOC) / Office of Emergency Services (OES): The County has had the need to open the EOC on multiple occasions within the last decade and the function of the EOC is an extremely important service provided by the County. There are two items listed for the EOC. Item 1 is the remodel of Building 35 for the EOC and item 13 is constructing a new EOC. The need and timing for Item 13 may be delayed or eliminated if a permanent solution is found with item 1.
- 2. Courthouse Relocation: The new Mendocino County Courthouse in Ukiah is scheduled to be complete in March of 2027 according to the California Courts website. This impacts several strategic plan items. Several County Departments serve the public in or near the Courthouse. The existing Courthouse will also be left entirely to the County when the Courts vacate the building. This asset should be sold to avoid substantial improvements that will be necessary to continue operations in this building. The items related to the Courthouse include: 2. District Attorney (DA), 3. Child Support Services, 17. Public Defender. The child support services building is dramatically underutilized and the site is a few blocks from the new Courthouse site. One option for the District Attorney is to renovate and add-on to the existing building 55 to be used at the DA's office. Another option could be to construct a new Public Safety building near the Courthouse that would include the DA and Public Defender. This public safety building could be enlarged to include other departments like Adult Probation, Child Support or Sheriff's Administration.



- **3. Family Center:** The current Family Center is located in a remodeled house that is in need of repair, better security and more functional space.
- 4. Sheriff's Office: The facilities at the Ukiah Sheriff's office have been used past their useful life expectancy. The list of deferred maintenance for these facilities is lengthy and the space is not organized efficiently. This item relates to the functions of Sheriff's Administration, Jail Administration, Detectives, Patrol 1, Jail Programs, and Jail Kitchen and Laundry. Several options exist for the replacement of this facility. The preferred solution will be the construction of a new Sheriff's Administration building that meets the Essential Services Building Seismic Safety Act (ESBSSA) requirements. Several of the functions listed above could be moved to another location if space and access to the existing site are limiting factors. This topic relates to Items 5,14 and 22.
- **5. Probation:** The Probation Office is in need of more space as well as space that is designed more efficiently to operate effectively. Buildings 26 and 38 will be enough space for the Adult Probation Department if they are remodeled adequately and the deferred maintenance items are addressed.

6. WISC, Dora St., Yokayo Center and Willits Justice Center:

- a. The Willits Integrated Service Center (WISC) includes two buildings that are underutilized. The departments using these buildings include Social Services (SS), Public Health, Mental Health and a couple of offices for Probation. The staff / services provided at these facilities could be consolidated either into one building, the Willits Justice Center or the offices in Ukiah or Fort Bragg.
- b. Dora St (building 56) is used by Public Health and Mental Health. The space within the building is not utilized as efficiently as it could be, especially when working remotely is factored into the efficiency. The space may be able to be re-organized to allow another department to move in to a portion of the building, or for some of the staff from Willits to relocate to Ukiah.
- c. Yokayo Center: South Yokayo, The Adults / Administration portion of SS is in need of a remodel, with this remodel, the efficiency of the building may be increased to allow for another department to move in or some the staff from Willits to relocate to Ukiah.
- d. Willits Justice Center: The existing County owned building is currently partially occupied by Cannabis and the Willits Police Department. The County could purchase and renovate the old Courts space. Or the County may be able to sell this building.



- 7. DOT: The Department of Transportation Facilities are in various states of disrepair and have multiple items of deferred maintenance that must be addressed soon. The County operates 6 Satellite road yards throughout the County and the main corporation yard and offices in Ukiah. A solution for addressing these road yards could be to construct a new metal building at each location to eliminate the facilities that are at the end of their usable life. Further analysis may be needed to determine if the road yards are in the correct location or if there needs to be 6 road yards.
- **8. Planning & Building:** The Ukiah Planning and Building department is not currently operating in efficient space. A remodel / re-organization of building 28PE would greatly improve their ability to operate effectively.
- **9. Jail:** The new Mendocino County Jail Addition will begin construction in the summer of 2023. This addition to the County will effect a few surrounding facilities. This addition to the Jail may allow for the oldest portion of the existing Jail "Main Jail" to be remodeled, replaced or demolished. Additional studies for the needs of the Jail as a system should be performed to verify the next steps for the Jail to operate efficiently. The "Main Jail" has multiple areas of deferred maintenance as well as operational inefficiency. Additionally, the General Services storage buildings, used by several departments will not have adequate access after the construction of the new jail. These facilities may need to be replaced.
- 10. Deferred maintenance Items: Each Phase of the Facilities Strategic Plan indicates a number of items that are in need of repair. The actual number of items addressed each year will ultimately be determined by the amount budgeted for replacement of existing systems. Typically items like mechanical systems and roofs that are failing cost significantly more in emergency repairs than if the systems are replaced / maintained on a regular basis.







