WHEREAS, by Resolution No. 17-189 adopted by the Board of Supervisors on December 19, 2017, the Board shall set the salaries and terms and conditions of employment for all the Elected Department Heads, Auditor-Controller, Assessor-Clerk Recorder and Treasurer-Tax-Collector and Elected Officials, District Attorney and Sheriff; and

WHEREAS, on December 14, 2021, the Board of Supervisors approved consolidating the positions of Auditor-Controller and Treasurer-Tax Collector into a single incumbent/single position effective January 2023; and

WHEREAS, it is the desire of the Board of Supervisors to amend said resolution to meet the needs of County service; and

WHEREAS, it is the intent of the Board of Supervisors to review the salaries and terms and conditions of employment and determine what adjustments, if any, shall be made, and

WHEREAS, on December 31, 2017, elected Department Heads and Elected Officials began receiving all eligible benefits included in the Department Head Memorandum of Understanding; and

WHEREAS, effective July 7, 2024, Elected Officials will begin receiving all eligible benefits included in the Unrepresented Employees Compensation and Benefit Resolution.

NOW, THEREFORE, BE IT RESOLVED that Mendocino County Board of Supervisors herby authorizes the salary of the below Elected Officials is established at the following levels:

Assessor-Clerk Recorder	\$161,100.00
Auditor-Controller Treasurer Tax Collector	\$179,792.65
District Attorney	\$217,380.00
Sheriff	\$213,350.00

The effective date of this Resolution shall be July 7, 2024, to coincide with the beginning of Pay Period 15-24.
