Departments and Divisions

Agriculture

As the holiday season approaches, the Department reminds ranchers, farmers, and growers to submit their crop statistics for Mendocino County's annual Crop Report. The 2022 and 2023 reports are available online, and we are now collecting data for 2024 and 2025.

Animal Care Services

The Animal Care Services program areas include Shelter, Clinic and Animal Protection Services. These programs provide animal education outreach, adoptions, volunteer opportunities, fostering, lost and found services, feral cat trap-neuter-release programs, dog licensing, low cost spay and neuter, animal health education, rabies vaccinations, micro-chipping, impounding of lost and stray animals, responding to injured, ill and suspected cruelty complaints, and promoting responsible pet ownership.

Our volunteers gave their time and energy in countless ways - walking dogs, socializing with cats, and supporting adoption events. Child Support

The Mendocino County Department of Child Support Services strives to "Help Parents Invest in their Children". Our mission is to serve children and their families by establishing parentage and enforcing support orders in a fair and equitable manner.

Effective County Government Organization

Child Support Services works to improve the well-being of children by securing consistent and reliable financial support from both parents. We establish and enforce support orders, provide parentage services, manage payments with fairness and accuracy, and assist families through compassionate and equitable case management.

A Thriving Economy

As of November 30, 2025, our caseload totaled 2,654 active cases. Over this period, the Department of Child Support collected \$406,326.32, successfully delivering \$361,655.15 in support directly to families throughout Mendocino County. These figures highlight our ongoing commitment to strengthening family stability and ensuring essential financial support reaches the children who need it.

Environmental Health

The Environmental Health Division of Public Health continues to progress toward the strategic initiative to digitize Land Use, Solid Waste, and Consumer Protection files. Once completed, the public and regulated facilities will benefit from faster access to records, enhanced transparency and service delivery, even while the department operates with reduced staffing.

The division is split between two offices, one coastal and the other inland. Full staffing for the division historically included 12 inspectors, 5 administrative staff, and 4 management staff. Over the past two fiscal years Environmental Health has received support to fill vacant fee supported positions, but very few qualified candidates applied to fill the various vacancies. Current staffing includes 6 inspectors, 3 administrative staff, and 3 management staff. As a result, staff resources are being shifted internally to assist with program mandates prioritized by public health risk factors. Field inspectors are conducting multiple program inspections when on-site, to utilize time more efficiently. Management staff are assisting with field work assignments as well as project plan reviews. All staff are supporting the public administrative needs whether that is via email, at front counters, or on the phone.

Executive Office - Budget/Fiscal

To address the budget deficit as part of the FY 2025-26 Adopted Budget, County General Fund departments were required to take a cut to their Salary and Benefits (1000 Series) based on a 6% attrition factor, which totaled \$5,246,657 across departments. This factor was calculated based on a historical average County-wide attrition rate. The 6% rate was conservatively adjusted to account for a degree of staffing variability throughout the fiscal year.

Based on year-to-date payroll actuals through December 12, 2025, plus utilizing the most recent payroll to annualize the remaining fiscal year payroll expenses, the County is anticipating realizing \$4,440,000 or a little under 85% of the total \$5,246,657. This has slightly decreased (.47%) from the last report.

The County must remain diligent and continue to follow the Strategic Hiring processes to realize the full attrition savings for FY25/26.

Additionally, the County must ensure one-time funds are utilized for one-time expenses.

Executive Office - Contract Unit

The Contract Unit works directly with departments Countywide to execute contracts and amendments to ensure alignment with County Policy. Since April of 2024, the Contract Unit has administered review processes for over 2,400 contract items, including over 525 items with effective dates on or after July 1, 2025. Additionally, as a result of the Board's first review of revisions to the County's Leasing and Contracting Policy (Policy No. 1) on October 7, 2025, the Contract Unit has been working to update Cobblestone approval workflows and Competitive Bidding tracking systems to align with new requirements.

Public Resources

Mendocino County maintains a publicly accessible portal where fully executed contracts can be viewed. The initial search screen of the portal allows users to search all County contracts by Department, Contract Number, Approving Authority, Contractor, and/or Keyword. Executive Office - Grants Unit

The Grants Unit advanced multiple priority initiatives in November, including conducting a Public Hearing to secure Board authorization to allocate the remaining 2024–25 CDBG Program Income, and working to finalize two PI applications, the County Business Loan Program and the Centro Negocio West Microenterprise Technical Assistance Project, to support entrepreneurs and job creation. Additionally, staff continues work on a major amendment to the CDBG MIT-RIP grant to align with new State Round 2 funding, to extend the grant through 2031, and reinstate key project enhancements to strengthen long-term infrastructure resilience.

During fiscal year 2025-26, the Grants Unit partnered with County departments to submit 3 grant applications totaling \$11.3 million. Additionally, the unit supports management of 15 grants exceeding \$16.2 million for the Executive Office.

Executive Office - Information Technology

County Website Upgrade

The Information Technology Division has partnered with Granicus to upgrade the County's website using their OpenCities platform. This upgrade will improve the public's online experience by making it easier to find County information, access services, and ensure the site meets modern accessibility standards. We will continue sharing updates as this work moves forward.

New County GIS Hub

Mendocino County's Information Technology Department has launched a new public-facing Geographic Information System (GIS) mapping application, available at https://gis.mendocinocounty.gov.

Developed with ESRI technologies including ArcGIS Experience Builder and ArcGIS Hub, the Hub site modernizes public access to geographic information by consolidating datasets, basemaps, and interactive mapping tools into a single resource. Visitors can utilize features such as printing, measurement, drawing, selections, and download publicly available GIS data in multiple formats. Future enhancements will include the addition of more datasets, a data library, and exploring possibilities of incorporating resources from other County departments to further improve public access to information.

Executive Office - Office of Emergency Services

Mendocino County Office of Emergency Services (OES) is the primary local coordination agency for emergencies and disasters affecting residents, public infrastructure, and government operations in the Mendocino County Operational Area (OA). The Mendocino County OA includes the county and its cities, towns, and special districts, in coordination with tribes.

OES attended the bimonthly Fire Chiefs meeting, the statewide Tsunami Steering Committee meeting, and hosted a Pre-Season Winter Weather Coordination meeting. The county experienced a couple of atmospheric rivers in early and mid-November. OES worked closely with the National Weather Service, monitored the hazardous weather, and shared messages to the public and operational area partners.

Executive Office - Prevention, Recovery, Resiliency, and Mitigation

During the month of November 2025, the Prevention, Recovery, Resiliency, and Mitigation (PRRM) team made significant progress across a range of projects designed to enhance Mendocino County's disaster preparedness and resilience. These projects are funded through various grants aimed at enhancing community resilience and disaster preparedness. Specific funding sources include FEMA's Hazard Mitigation Grant Program (HMGP), CAL FIRE grants, the Department of Water Resources (DWR), the Building Resilient Infrastructure and Communities (BRIC) program, and Community Development Block Grant Planning and Public Service (CDBG-PPS) funds. Staff also finalized proposals, issued and reviewed RFPs, and prepared contracts for submission to the Board of Supervisors for approval. Despite ongoing challenges such as federal funding uncertainties and project delays, the team remains on track to meet critical upcoming milestones through late 2025 and into 2026.

Planning and Building

The Department of Planning and Building Services ("PBS") continues to advance its mission of delivering effective, transparent, and responsive service to the Mendocino County community. This quarter, key accomplishments include the Board of Supervisors' approval of a new permit management system, Accela, which is expected to streamline the permitting process and enhance the user experience. The Department also prioritized staff development and training, implemented strategic staffing adjustments to support fiscal responsibility, and maintained accurate metric reporting to promote transparency and operational efficiency.

In November, PBS welcomed two new team members and recognized the retirement of a dedicated public servant whose contributions are deeply appreciated. The Department also applied for the latest round of the Cannabis Equity Grants Program, with award notifications anticipated in early 2026. Throughout the past month, monthly performance metrics continued to serve as a key tool for public accountability, offering valuable insight into departmental workload, revenue, and service timelines. Additionally, PBS would like to remind the community that the 2025 California Building Code will take effect on January 1, 2026.

Looking ahead, PBS remains committed to strengthening internal operations, enhancing service delivery, and supporting a resilient, well-equipped team. Through the adoption of new technologies, continued investment in staff, and a focus on emergency preparedness, the Department is dedicated to continuous improvement and serving the residents of Mendocino County with integrity and professionalism.

Updates from the State

\$18 Billion to the Bad: LAO Releases New Fiscal Outlook

The Legislative Analyst's Office (LAO) is projecting an \$18 billion budget deficit in its newly released Fiscal Outlook for the 2026-27 state budget.

The annual report provides the first formal assessment of the state's fiscal condition heading into the upcoming budget cycle and underscores the likelihood of another challenging year for state and local programs.

According to the LAO, the projected \$18 billion shortfall reflects ongoing revenue softening and higher baseline costs, setting the stage for difficult budget deliberations when lawmakers return in January. Counties should expect deficit-driven conversations to shape early negotiations. The full Fiscal Outlook is available here for those interested in a deeper review of the state's fiscal trends.

The Future of Medi-Cal Commission

As reported by Politico, with California bracing for an \$18 billion budget deficit and significant federal Medicaid cuts, major nonprofits and policy groups were prompted to form the Future of Medi-Cal Commission—a new independent body tasked with shaping a 10-year modernization plan for the state's largest and most expensive program. The Commission will begin meeting in January and focus on long-term financing, state—county administrative coordination, and strategies to improve care for individuals with complex behavioral health needs. With Medi-Cal accounting for 40% of the state budget and federal cuts projected to reach \$1 billion next year and up to \$5 billion by 2029, the group's recommendations—expected in early 2027—are likely to shape legislative debates and guide the next governor's approach to Medi-Cal reform.

County Indigent Care Programs

Recent policy changes enacted under H.R. 1 are expected to significantly reduce Medicaid enrollment in California. As a result, policymakers, advocates, and media outlets have begun inquiring about county medically indigent programs—specifically how counties are preparing for an increase in the uninsured population and what county requirements entail.
