## THIRD AMENDMENT TO COUNTY OF MENDOCINO AGREEMENT NO. PA-24-21

WHEREAS, Agreement No. PA-24-21 was entered into on July 1, 2024 (the "Initial Agreement"); and

WHEREAS, first Amendment to Agreement No. PA-24-21 was entered into on February 25, 2025 (the "First Amendment") increasing the total amount by \$50,000 for a new total of \$100,000; and

WHEREAS, second Amendment to Agreement No. PA-24-21 was entered into on April 15, 2025 (the "Second Amendment") extending the end date from June 30, 2025 to June 30, 2026; and

WHEREAS, the Initial Agreement, First Amendment, and Second Amendment are referred to as the Agreement; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this third Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total amount payable by \$12,000 from \$100,000 to \$112,000.

NOW, THEREFORE, we agree as follows:

1. The total contracted amount set out in the Agreement is hereby increased by \$12,000 from \$100,000 to \$112,000.

All other terms and conditions of the Agreement shall remain in full force and effect.
