**FIFTH AMENDMENT TO COUNTY OF MENDOCINO  
AGREEMENT NO. BOS 18-126**

This fifth Amendment to Agreement No. BOS 18-126 is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Redwood Toxicology Laboratory, Inc., hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. BOS 18-126 was entered into on August 23, 2018; and

WHEREAS, First Amendment No. BOS 18-126-A was entered into on August 23, 2022; and

WHEREAS, Second Amendment No. BOS 18-126-B was entered into on February 22, 2023; and

WHEREAS, Third Amendment No. BOS 18-126-C was entered into on May 18, 2023; and

WHEREAS, Fourth Amendment No. BOS 18-126-D was entered into on May 22, 2024; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date from December 31, 2024 to June 30, 2025; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total contract amount from Two Hundred Thousand Dollars (\$200,000.00) to Two Hundred Twenty Five Thousand Dollars (\$225,000.00).

NOW, THEREFORE, we agree as follows:

1. The termination date is hereby extended from December 31, 2024 to June 30, 2025.
2. The total contracted amount is hereby increased from Two Hundred Thousand Dollars (\$200,000.00) to Two Hundred Twenty Five Thousand Dollars

(\$225,000.00).

All other terms and conditions of Agreement No. BOS 18-126 shall remain in full force and effect.
