# **Program Description**

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, BJA seeks to support small and rural agencies in their efforts to combat violent crime.

# **Statutory Authority**

Bipartisan Safer Communities Supplemental Appropriations Act, 2022 (Pub. L. No. 117-159, 136 Stat. 1313, 1339); 28 U.S.C. 530C and Consolidated Appropriations Act, 2023, Public Law 117-328.

#### **Specific Information**

Reducing violent crime requires a multifaceted, collaborative, evidence-informed, innovative strategy, and there are a wide variety of tools and subject matter experts available to help law enforcement perform this important work. However, all jurisdictions have their own challenges, stakeholders, and resources. Consequently, there is no singular or static solution to reducing violent crime.

Several years ago, the Bureau of Justice Assistance, in partnership with Major Cities Chiefs Association, developed and released the <u>Violent Crime Reduction Operations Guide</u> to assist jurisdictions in their efforts to combat violent crime. The <u>Violent Crime Reduction Operations</u> Guide outlines actions and activities that can adapt to any agency. This guide and its principles have contributed to the development and implementation of successful crime-fighting strategies throughout the country.

The guide outlines "Critical Elements," which are essential components of crime-fighting strategies. Each element is described in a format that can assist agency executives to conduct assessments of their agency's capacity in each respective area. An executive uses the guide to determine the level at which their agency is working in a particular area.

BJA later partnered with AEquitas to develop a companion tool, the <u>Prosecutors' Guide to Reducing Violence and Building Safer Communities</u>, which also outlines critical crime reduction strategic principles for prosecutors' offices through a continuum of crime reduction capacities.

This program will provide funding to small and/or rural agencies and/or to prosecutors who are interested in implementing or improving the capacity of their organization around one or more critical elements found in the *Violent Crime Reductions Operations Guide* or the *Prosecutors' Guide to Reducing Violence and Building Safer Communities*. Applicants are also encouraged to review the resources available on the Public Safety Clearinghouse for strategic solutions.

# Goals, Objectives, and Deliverables

#### Goals

The goal of this program is to increase the capacity of police departments or prosecutors' offices to fully implement the critical elements found in the guides to build capacity to combat violent crime.

#### **Objectives**

An applicant should address all the objectives listed below in the Goals, Objectives, Deliverables, and Timeline web-based form.

To provide funding to strengthen the capacity of a rural or small jurisdiction to combat violent crime through enhanced implementation of critical elements.

To provide tools and resources need to implement critical elements.

#### **Deliverables**

- 1. Complete the Violent Crime Reduction Operations Guide online assessment tool provided to successful applicants.
- 2. Select one or more of the critical elements within the guide to improve capacity as part of an overall violent crime reduction strategy. The strategy should incorporate the key concepts:
  - A. Community collaboration
  - B. Criminal justice partner cooperation
  - C. Victim-centered approaches
  - D. Evidence-based strategies
  - E. Commitment to measuring crime reduction outcomes in meaningful terms, commensurate with the scope of the violence problem and funding amount requested
- 3. Partner with a researcher or subject matter expert to plan, execute, and monitor the capacity-enhancement activities selected to ensure organizational growth within the capacity area and a direct link to the crime reduction strategy. Strategies may necessitate the purchase of technology. This should be part of a comprehensive plan and should be adequately justified in the implementation stage. Submit this plan to BJA prior to implementation.
- 4. Implement programming and activities that reflect an enhanced capacity in these areas, per the guide. Deploy agency resources such as personnel, services, or analytical tools that meet the capacity enhancement goal.
- 5. Document the development and implementation of strategies to reduce the violent crime problem or problems identified in their applications. These program descriptions should be memorialized in official agency documents and in a manner consistent with professional standards. Relevant agency policies and procedural manuals should be developed and/or

updated as necessary.

- 6. Track progress and outcomes, making adjustments as needed.
- 7. Participate and/or host a regional "crime fighters conference" in collaboration with BJA.
- 8. Provide a final report of activities and outcomes to BJA.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

In support of this <u>Executive Order</u>, OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this

requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

2. Priority Considerations Supporting Executive Order 14074, Advancing Effective, Accountable Policing and Criminal Justice Practices to Enhance Public Trust and Public Safety

Executive Order 14074, Advancing Effective, Accountable Policing and Criminal Justice Practices to Enhance Public Trust and Public Safety requires the Attorney General, through discretionary grantmaking and training and technical assistance, to encourage and support State, Tribal, local, and territorial governments and law enforcement agencies to adopt the policies, best practices, and guidelines addressed in the executive order, including, but not limited to: (i) investigating deaths in custody; (ii) recruiting and retaining diverse and service-oriented law enforcement professionals; (iii) collecting and reporting use of force and misconduct data; (iv) improving community and law enforcement dialogue; (v) responding to individuals in mental health crisis or with disabilities; (vi) the proper and responsible use of technology; (vii) restrictions on unannounced entries and certain restraints; (viii) addressing implicit bias; (ix) restricting the use of militarized equipment;? (x) broader criminal justice reform; and, (xi) officer wellness and mental health.

As such guidance is developed in accordance with the executive order, and where the guidance is applicable to the specific solicitation, DOJ will identify specific opportunities for training and technical assistance and priority consideration for applications that demonstrate or seek to support the policies of the Executive Order.

For the purposes of this solicitation, OJP and COPS will provide priority consideration for the following items, for which the DOJ has already issued policies, guidance, and/or best practices:

- 1. participation in the collection and reporting to DOJ of data on law enforcement use of force and deaths in custody;
- 2. participation in the collection and reporting to DOJ of data on officer suicides and officers killed and assaulted:
- 3. restrictions on unannounced entries and neck/carotid restraints; and,
- 4. restrictions on the possession and use of militarized equipment.

To receive this consideration, the applicant must describe how they currently support one or more of the identified policy areas or how the proposed project(s) will address one or more of the identified policy areas.

Note: Addressing these priority areas is one of many factors that OJP considers in making

funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

- (2) A "rural agency," as defined under this initiative, is (a) an agency serving any area or community, no part of which is within an area designated as a standard metropolitan statistical area by the Office of Management and Budget or (b) any agency serving one or more rural census tracts.

(3) A tribal agency is any federally recognized tribe with a designated law enforcement agency.

For information on cost sharing or match requirements, see the "Federal Award Information" section.

**Notice regarding law enforcement agencies:** State, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process to be eligible for FY 2023 DOJ discretionary grant funding. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency's use-of-force policies adhere to all applicable federal, state, and local laws, and (2) the agency's use-of-force policies prohibit chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a subaward. # **Proposal Abstract**

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract.

# **Proposal Narrative**

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 10 numbered pages. If the Proposal Narrative fails to comply with these length restrictions, BJA may consider such noncompliance in peer review and in final award decision.

The Proposal Narrative must include the following sections:

#### a. Description of the Issue

Describe why this project/these proposed activities are necessary (significance/value) or address a need. Include supporting information regarding the violent crime problem. Applicants must describe in detail how they meet the criteria for small, rural, or tribal agencies as outlined in the Eligibility section.

#### b. Project Design and Implementation

Describe the strategy to address the needs identified in the Description of the Issue, consistent with the goal and objectives outlined in the solicitation. List the activities and describe how they relate to the stated objectives. Activities are the specific actions to be undertaken to fulfill the program's objectives and reach the program's goal(s). Provide a detailed description of the method(s) to be used to carry out each activity. Provide a timetable indicating roughly when the activities or program milestones are to be accomplished.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

#### c. Capabilities and Competencies

Describe the capabilities and competencies required to accomplish the goals and objectives of the project. Applicants must include a description of the qualifications of the researcher or subject matter expert partnering on the project as described under the Deliverables section.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Identify who will collect the data, who is responsible for performance measurements, and how the information will be used to guide and evaluate the project's impact. Describe the process to accurately report data.

Note: An applicant is **not** required to submit performance data with the application. Rather, performance measure information is included as a notification that award recipients will be required to submit performance data as part of each award's reporting requirements. Some measures are presented as examples, while others are the exact measures that every recipient will be expected to address.

OJP will require each award recipient to submit regular performance data that show the completed work's results.
