RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD TWO DEPARTMENT OF TRANSPORTATION CONTRACTS TO CONSTRUCT THE 2023 HIGHWAY SAFETY IMPROVEMENT PROGRAM PROJECTS: GUARDRAIL UPGRADES AND SYSTEMIC ROADWAY SEGMENT IMPROVEMENTS, AT AN ESTIMATED COST OF \$1,200,000 (COUNTYWIDE)

WHEREAS, the Mendocino County Department of Transportation (DOT) is desirous of performing upgrades to existing guardrails and end treatments at areas with a high probability of vehicles unintentionally exiting the roadway; and

WHEREAS, the locations found necessary for upgrading existing guardrails and end treatments are East Side Potter Valley Road, County Road (CR) 240, at mile post (M.P.) 6.00 and 6.21; Point Cabrillo Drive, CR 564, at MP 2.65 and 2.85; Babcock Lane, CR 207, at MP 0.10; Primrose Drive, CR 604, at MP 1.60; and Comptche-Ukiah Road, CR 223, at MP 7.30; and

WHEREAS, the Mendocino County DOT is desirous of performing the installation of roadway safety signs at areas based on severity of need, average daily traffic, and history and likelihood of injury occurring per accident analysis; and

WHEREAS, the work will include the installation/upgrade of signs with new fluorescent sheeting (regulatory or warning) and the installation of chevron signs on horizontal curves, delineators, reflectors, and/or object markers will be placed along Branscomb Road, CR 429; East Side Calpella Road, CR 227; North State Street, CR 104; Sherwood Road, CR 311; Comptche Ukiah Road, CR 223; Simpson Lane, CR 414; Vichy Springs Road, CR 215; Valley Road, CR 309; South State Street, CR 104A; Mountain View Road, CR 510; Pudding Creek Road, CR 421; Eel River Road, CR 240B; and Henderson Lane, CR 337N; and

WHEREAS, these two DOT contracts will provide for construction of the 2023 Highway Safety Improvement Program (HSIP) projects on various County roads, at an estimated cost of \$1,200,000; and

WHEREAS, funding for Fiscal Years (FY) 2024-25 and 2025-26 is budgeted through Budget Unit (BU) 3041, and is anticipated to be 90% reimbursable through the Federal Highway Administration (FHWA); and

WHEREAS, under Section 20395 of the California Public Contract Code, the Board of Supervisors may authorize the Director of Transportation to execute contract change orders subject to certain cost limitations; and

WHEREAS, the Director of Transportation recommends and requests authorization to proceed with the advertisement and award of these two DOT contracts to upgraded guardrails and roadway safety signs.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

 Authorizes and directs the Director of Transportation to sign the Notice to Bidders, inviting bids for construction of various road improvements mentioned above, upon receiving the funding authorization from approving agencies to proceed with such action; and 2. Authorizes and directs the Director of Transportation to award the above mentioned DOT contracts, upon confirmation of appropriate low bidders and acceptable contract documents by County Counsel and Risk Management, and report results to the Board through the applicable Chief Executive Officer's Report.
