5a. Update and Discussion on Riparian Corridor and Wetlands White Paper (Pallesen)

Vice Chair Pallesen gave an update on the progress of the paper he co-wrote with Commissioner Madigan and the presentation he gave to the County Board of Supervisors

5b. Discussion and Possible Action on submitted 2022 Grant Application for Propagation Funds

A short discussion was held on the number of grants that were received and Chair Neumann insured that all Commissioners had the appropriate information before the Commission began their discussion. Everyone was prepared.

MOTION: Vice Chair Pallesen made a motion to increase the funding limit to \$51,000, 2nd by Commissioner Pellar. Approved 5-0-0

A presentation was given by Olivia from Mendocino Wildlife on the Fawn Rescue grant. Commissioners asked questions and Olivia was given a chance to respond.

It was decided that Commissioner Pellar would recuse herself from voting on the Mendocino Wildlife grant as she founded the program. Commissioner Madigan would be able to vote on the Mendocino Land Trust grant, it has been over 20 years since she worked as a contractor for them.

Commissioners took a short break to score the remaining grants with the criteria sheets provided to them.

would take 3 months before the Board of Supervisors would see that grant approvals on their agenda. Commissioner Madigan took the lead on writing a provisional award letter to the grantees that detailed the next steps.
