RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS APPOINTING SUPERVISOR MADELINE CLINE AS DIRECTOR AND SUPERVISOR MAUREEN MULHEREN AS ALTERNATE DIRECTOR TO SERVE ON THE UKIAH VALLEY BASIN GROUNDWATER SUSTAINABILITY AGENCY BOARD OF DIRECTORS FOR THE TERM BEGINNING JANUARY 1, 2025 (UKIAH AREA)

WHEREAS, groundwater located in the Ukiah Basin is a vital resource to meet the water supply needs for residents, visitors and businesses of Mendocino County; and

WHEREAS, the County of Mendocino, City of Ukiah, Upper Russian River Water Agency and Russian River Flood Control and Water Conservation Improvement District have come together to improve management of groundwater in the Ukiah Valley Basin under a Joint Powers Agreement (JPA) creating the Ukiah Valley Basin Groundwater Sustainability Agency; and

WHEREAS, each of the member agencies is a local agency as defined by the Sustainable Groundwater Management Act of 2014 (SGMA), duly organized and existing under and by virtue of the laws of the State of California with the ability to exercise powers related to groundwater management; and

WHEREAS, Article 7 of the JPA provides for the appointment of Directors and Alternate Directors by resolution of each governing body, to serve on the Board of Directors as representatives of each member agency; and

WHEREAS, on January 7, 2025, the Board of Supervisors selected Supervisor Madeline Cline as Director and Supervisor Maureen Mulheren as Alternate Director to serve on the Ukiah Valley Basin Groundwater Sustainability Agency Board of Directors for the term beginning January 1, 2025; and

WHEREAS, it is now appropriate to adopt the resolution appointing Supervisor Madeline Cline as Director and Supervisor Maureen Mulheren as Alternate Director to serve on the UVBGSA Board of Directors for the term beginning January 1, 2025.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Appoints Madeline Cline to serve as the Director representing the County of Mendocino on the Board of Directors for the Ukiah Valley Basin Groundwater Sustainability Agency for the term beginning January 1, 2025; and
