

**THIRD AMENDMENT TO COUNTY OF MENDOCINO
AGREEMENT NO. EO-22-35**

This Amendment to Agreement No. EO-22-35 is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and CLIENT FIRST CONSULTING GROUP, LLC DBA CLIENTFIRST TECHNOLOGY CONSULTING, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. EO-22-35 was entered into on June 29, 2022; and

WHEREAS, First Amendment No. EO-22-35-A1 was entered into on May 30, 2023; and

WHEREAS, Second Amendment No. PA-24-18 was entered into on August 22, 2023; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date set out in first Amendment Agreement No. EO-22-35-A1, from June 30, 2024, to June 30, 2025; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase The total contracted amount set out in the second Amendment Agreement No. PA-24-18 by \$10,000 for the continued need of services as defined in Exhibit A, of original Agreement No. EO 22-35 for a new total contract amount of \$40,000.00.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the first Amendment Agreement No. EO-22-35-A1 is hereby extended from June 30, 2024, to June 30, 2025.
2. The total contracted amount set out in the second Amendment Agreement No. PA 24-18 is hereby increased from \$30,000.00 to \$40,000.00.

All other terms and conditions of Agreement No. EO-22-35, first Amendment Agreement No. EO-22-35-A1, and second Amendment Agreement No. PA-24-18 shall remain in full force and effect.
