As the mission of the Mendocino County Library states, we wish to "enrich lives through free and equitable access to materials." Furthermore, "our vision is an informed, connected, inclusive, and creative community where opportunities for discovery are valued." One of the challenges our county library faces is accessibility for those living in remote places of our county who are not close to their local library. Additionally, our Library system has limited funds for our collection of 157,290 items. Zip Books provides us with the opportunity to provide unique materials that promote access and encourage interaction with the community when they return Zip Books which may be added to help in diverse collection development. This opportunity provided by the Zip Books program also results in patrons being drawn into the library and potentially become more actively engaged with books and other library services that we offer.

We have provided Zip Books for several years and already have a successful system in place to offer this service. We offer Zip Books on our website with an online form, during outreach services, on our Bookmobile which offers services throughout our most remote locations in our rural county. By providing the Zip Books service we are providing the fastest possible service to provide reading materials to our remote patrons in comparison to the regular interlibrary loan or purchasing process.

Mendocino County Library is situated in the mostly rural northern California area above San Francisco. We have six branches situated in some of the towns, and a Bookmobile which drives 22,000 miles each year to provide materials to remote county locations. The poverty level in the county is 16% according to CSL's PolicyMap, with a significant portion of residents not able to receive reliable internet and some who don't have access to transportation. Zip Books allows "free and equitable access" in the Library's mission to obtaining materials that will reach many people. The desired outcome and goals of the program matches our vison to have a more "informed, connected, inclusive and creative community" where those we serve have the "opportunity for discovery" by being able to read books that aren't in our collection, as well as Strategic Plan collection objective to "reflect the community where it's located."

The Zip Book Project is one of our most popular offerings, with many patrons asking when the program will be restarted after the end-of-year pause. Many patrons would like to be able to order more items. Feedback includes patrons saying they are very happy with the programs, that their items are delivered quickly, and the transactions spark conversations between patrons and staff. Please see the letter to the editor in the supplemental documents praising the Zip Books program and staff.

This year the focus has been on ordering and retention of Zip Book items that are more likely to add diversity to and enrich the collection in a way that benefits our community. We have learned to be more discriminating when ordering books such as avoiding items that are not sold by or shipped directly from Amazon. Books that are older or very obscure books are less likely to hold up well or circulate much. With the rare exception, we only order "new" items, and we do not order from third party sellers. There is a greater likelihood that new items will be in the condition promised and will arrive when they are expected. Additionally, there is far less difficulty when it comes to communication or refunds if anything goes wrong. And most importantly, we are more likely to add these Zip Book items that are more current and hopefully still in close-to-new condition when they are returned.

Zip Books are a much-needed resource in our rural community, providing the option of having library materials sent directly to patrons, circumventing the need to "go to town" to get these materials. Mendocino County has 3,878 square miles of many remote and underserved communities where library access is limited and includes those who are less likely to have consistent or regular access to their local library materials, programs, and other services. In addition to poverty and lack of adequate broadband, the barriers include the shortage of public transportation, the cost of gas and vehicle maintenance to make a trip to the library, and the time to drive there which can take hours. By promoting Zip Books to these outlying areas through outreach events and Bookmobile services, it helps to bring in new library users by reducing the requirements needed to access library services.

COMMUNITY ENGAGEMENT

Community Engagement Response *

Mendocino County's indigenous residents are underrepresented members of our community, and we provide library outreach events and promote the Zip Books Project by providing fliers and discussing it with event attendees. Mendocino County has eleven reservations with at least six tribes represented. Zip Books are offered to gain access to hard-to-find diverse materials about the history, language, and literature written by and for native people. The Library also attends outreach events which are more likely to reach those who may not use library services such as farmworkers and low-income people who don't live near to or may be unfamiliar with the library. This fiscal year to date, the library has provided informational and activity booths and staff at 202 offsite events with 15,705 attendees to promote library services such as Zip Books and reach those communities which may be underserved.

Based on previous years' Zip Books statistics and with the requested funding of \$14,000, we expect to serve 275 library patrons, with approximately 400 items added to the library's collection.

We hope the State funding continues or we will consider pursuing outside sources to fund purchases to continue the program on our own.
