AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 21-165

This Amendment to BOS Agreement No. 21-165 is entered into this __5th__ day of April ____, 2022, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Abbott & Kindermann, Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 21-165 was entered into on September 15, 2021; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Abbott & Kindermann, Inc., this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>21-165</u> from June 30, 2022 to December 31, 2022; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total amount set out in the original BOS Agreement No. <u>21-165</u> from \$10,000 to \$20,000.

NOW, THEREFORE, we agree as follows:

- The termination date set out in the original BOS Agreement No. <u>21-165</u> shall be extended from June 30, 2022 to December 31, 2022; and
- 2. The total amount set out in the original BOS Agreement No. <u>21-165</u> shall be increased from \$10,000 to \$20,000.

All other terms and conditions of BOS Agreement No. 21-165 shall remain in full force and effect.
