AN ORDINANCE CHANGING THE ZONING OF REALPROPERTY WITHIN MENDOCINO COUNTY

Pursuant to Division I of Title 20, Chapter 20.212 of the Mendocino County Code, the zoning of the following real property within Mendocino County is hereby changed as described below.

Said zoning change encompasses the portions of the properties described by Assessor's Parcel Number 131-110-16 and 131-110-17 located within the Inland Area (Division I of Title 20 of Mendocino County Code) which are reclassified from RL: 160 (Rangeland -160 acre minimum) to TPZ: 160 (Timberland Production Zoning District -160 acre minimum) as shown on attached Exhibit A.
