**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. BOS 20-149**

This Amendment to BOS Agreement No. BOS 20-149 is entered into this 17th day of Oct , 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Universal Protection Service, LP dba Allied Universal Security Services, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. BOS 20-149 was entered into on November 3, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Universal Protection Service, LP dba Allied Universal Security Services, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. BOS 20-149, from November 14, 2023 to November 14, 2024; and

WHEREAS, BOS Agreement No. BOS 20-149 provided for an option to extend the Agreement for up to three (3) consecutive one (1) year periods and an increased amount of \$300,000 will result in a new total contract not-to-exceed amount of \$1,301,520.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 20-149 will be extended from November 14, 2023 to November 14, 2024.
2. The amount set out in BOS Agreement No. BOS 20-149 will be increased by \$300,000; from \$1,001,520 to \$1,301,520.
3. The Payment Terms, Exhibit B set out in BOS Agreement No. BOS 20-149 has been altered and a new Payment Terms, Exhibit B, is attached herein with changes denoted in bold font.

All other terms and conditions of BOS Agreement No. BOS 20-149 shall remain in full force and effect.

EXHIBIT B

PAYMENT TERMS

A. COUNTY shall pay CONTRACTOR per the following instructions:

1. Contract Totals

- a. CONTRACTOR's annual contract total was calculated using a 40-hour work week, 50-week year, excluding estimated holiday closures annually. If holiday coverage is required or the COUNTY requires staffing beyond the hours the building is open, these numbers will be adjusted.
- b. CONTRACTOR has been selected to provide services described in Exhibit A, Definition of Services, and the compensation shall not exceed **One Million Three Hundred One Thousand Five Hundred Twenty Dollars (\$1,301,520) for the term of this Agreement.**
- c. **Security Professional Hourly Billed Rates:**

Current Regular Hourly Billed Rates

Five (5) Security Professionals: 200 hours/week @ \$26.25/hour

One (1) Security Supervisor: 40 hours/week @ \$29.25/hour

New Regular Hourly Billed Rates Effective January 1, 2024

Five (5) Security Professionals: 200 hours/week @ \$30.00/hour

One (1) Security Supervisor: 40 hours/week @ \$33.00/hour

2. CONTRACTOR will submit invoices addressed to:

3. If additional guards are required, the additional cost to the COUNTY will be based on hourly wages as set forth in Exhibit B, Payment Terms, Item 1-c. If circumstances require, the COUNTY may reduce services of guards required herein. In any event, the COUNTY will pay for only those services actually received.
4. Cost overruns and/or failure to perform within the maximum compensation ceiling established shall not relieve CONTRACTOR of responsibility to provide those services specified in Exhibit A, Definition of Services.

EXHIBIT B (continued)

5. COUNTY shall process approved invoices, and payment for said invoices shall occur within 15-days of the date the invoice is received.
6. If minimum staffing levels are not met, and COUNTY chooses to continue this Agreement, a credit to the COUNTY shall be given for the amount of that person's salary.
7. Payments under this **amended agreement shall not exceed One Million Three Hundred One Thousand Five Hundred Twenty Dollars (\$1,301,520) for the term of this Agreement.**
