RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS REQUESTING THAT THE CALIFORNIA DEPARTMENT OF TRANSPORTATION GRANT ITS PERMISSION FOR THE MENDOCINO COUNTY FAIR AND APPLE SHOW PARADE IN BOONVILLE PURSUANT TO THE DEPARTMENT OF TRANSPORTATION AND CALIFORNIA HIGHWAY PATROL'S JOINT POLICY GUIDELINES FOR SPECIAL EVENTS ON STATE CONVENTIONAL HIGHWAY RIGHTS-OF-WAYS

WHEREAS, the Mendocino County Fair and Apple Show wishes to hold a parade in connection with their annual Fair and Apple Show; and

WHEREAS, said parade will be held from 12:00 p.m. to 1:30 p.m. on September 15, 2019, commencing at 18200 Mountain View Road and proceeding in one lane on Highway 128 to the fairgrounds, ending at 14400 Highway 128; and

WHEREAS, in order for the parade to be held, the Mendocino County Fair and Apple Show needs to seek support from the Mendocino County Board of Supervisors, pursuant to the Department of Transportation and California Highway Patrol's Joint Policy Guidelines for Special Events on State Conventional Highway Rights-of-Ways to conduct a parade.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors does hereby support the Mendocino County Fair and Apple Show Parade and seeks the support and cooperation of any involved agencies.

BE IT FURTHER RESOLVED that the Mendocino County Board of Supervisors does hereby state that any liabilities and responsibilities shall rest with the parade sponsors.

BE IT FURTHER RESOLVED that the Mendocino County Board of Supervisors requests the California Department of Transportation to give its permission pursuant to the California Department of Transportation and California Highway Patrol's Joint Policy Guidelines for Special Events on State Conventional Highway Rights of Ways to the Mendocino County Fair and Apple Show to hold a parade on September 15, 2019, on Highway 128 in Boonville, California.



The foregoing Resolution introduced by Supervisor McCowen, seconded by Supervisor Williams, and carried this 23 day of April, 2019, by the following vote:




