

**RESOLUTION NO. 21-018**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AMENDING THE POSITION ALLOCATION TABLE PROVIDING THE NUMBER AND COMPENSATION OF OFFICERS, DEPUTIES AND EMPLOYEES IN THE VARIOUS OFFICES OF THE COUNTY OF MENDOCINO**

WHEREAS, the Board of Supervisors has adopted Resolution No. 20-079 which sets forth the classifications, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the wish and desire of the Board of Supervisors to amend this resolution to meet the needs of County service; and

WHEREAS, the affected departments or agencies have demonstrated a need for the position allocation amendments herein and have agreed to incorporate the positions within their existing fiscal year budgets; and

WHEREAS, the Civil Service Commission adopted the proposed classification of Senior Environmental Compliance Specialist and title change of Deputy Director Transportation – Solid Waste to Deputy Director Transportation – Solid Waste and Water Resources at its January 20, 2021 meeting; and

WHEREAS, the proposed wage of Senior Environmental Compliance Specialist has been aligned at ten percent (10%) above Environmental Compliance Specialist, it should receive wage adjustment necessary to maintain that alignment in July 2021, concurrent with Service Employees' International Unit (SEIU) Memorandum of Understanding; and

WHEREAS, the proposed wage of Deputy Director Transportation - Solid Waste and Water Resources has been aligned with Deputy Director Transportation – Maintenance Services and Deputy Director Transportation – Land Improvement, it should receive wage adjustment necessary to maintain that alignment in October 2021, concurrent with Management Association Memorandum of Understanding.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby authorizes the Position Allocation Table of said Resolution to be amended accordingly:


*The effective date of this Resolution shall be March 4, 2021, to coincide with the beginning of Pay Period 8-21.*


