NOW, THEREFORE, we agree as follows:

- 1. Paragraph 3)b. of Agreement No. <u>LS#21-13</u> is hereby amended to read as follows:
 - "b. The lease will terminate on August 1, 2029."
- 2. COUNTY will continue to pay monthly rent to CALNEVA pursuant to the terms of Paragraph 4) of Agreement No. <u>LS#21-13</u>.

All other terms and conditions of Agreement No. <u>LS#21-13</u> shall remain in full force and effect.
